- 5. If there is a large number of people interested in the same item as you, try to nominate three representatives to speak on your behalf and to indicate how many people they are representing.

This impacts on speakers who have to wait until very late, as well as City staff and Councillors who are required to remain focused and alert until very late. Grants and Sponsorship - Social Grants

File No: \$117676

Summary

The City of Sydney's Grants and Sponsorship Program supports initiatives and projects that build the social, cultural, environmental and economic life of the city and assist in the recovery from the Covid-19 pandemic. To achieve the objectives of the Community Recovery Plan and Sustainable Sydney 2030, genuine partnership between government, business and the community is required.

The provision of grants and sponsorships is a mechanism to further the aims identified in the City's social, cultural, economic and environmental policies. Applications are assessed against these policies and against broad City objectives and plans. In this way, the City and the community act collaboratively to achieve the goals of the Community Recovery Plan and Sustainable Sydney 2030.

The City advertised the following three grant programs in the annual Grants and Sponsorship Program for approval in 2021/22 and payment in 2022/23:

- Community Services Grant Program;
- Festivals and Events Sponsorship Program (Village and Community); and
- Matching Grant Program.

For the Community Services Grant Program, 60 eligible applications were received. This report recommends a total of 17 grants to a total value of \$926,888 in cash and \$55,961 value-in-kind for the 2022/23 financial year, and commitments of \$261,746 in cash for the 2023/24 financial year and commitments of \$263,078 in cash for the 2024/25 financial year.

For the Festivals and Events Sponsorship (Village and Community) Program, 27 eligible applications were received. This report recommends a total of 18 grants to a total value of \$592,950 in cash and \$141,136 value-in-kind for the 2022/23 financial year, and commitments of \$111,000 in cash and \$11,018 value-in-kind for the 2023/24 financial year and commitments of \$96,000 in cash and \$11,018 revenue foregone/value-in-kind for 2024/25 financial year.

For the Matching Grant Program, 37 eligible applications were received. This report recommends a total of 16 grants to a total value of \$99,815, in cash and \$11,700 value-in-kind for the 2022/23 financial year.

On 22 February 2021, Council adopted a revised Grants and Sponsorship Policy. All grants in this report were assessed in accordance with the Grants and Sponsorship Policy, the Grants and Sponsorship Guidelines, the priorities set out in the Community Recovery Plan and various other relevant City strategies and action plans.

All grant recipients will be required to sign a contract, meet specific performance outcomes and acquit their grant. All figures in this report exclude GST.

Recommendation

It is resolved that:

- (G) Council note that all grants amounts are exclusive of GST;

Background

- 1. The City of Sydney's Grants and Sponsorship Program supports residents, businesses and not-for-profit organisations to undertake initiatives and projects that build the social, cultural, environmental and economic life of the city.
- 2. On 22 February 2022, the City announced the grants program for approval in 2021/22 and payment in 2022/23 as being open for application on the City's website, with grant applications closing on 11 April 2022.
- 3. The three social programs promoted were:
 - (a) Community Services Grant Program;
 - (b) Festivals and Events Sponsorship (Village and Community) Program; and
 - (c) Matching Grant Program.
- 4. Information about these grant programs (such as application dates, guidelines, eligibility criteria and sample applications) was made available on the City's website. The City actively promoted the program through Facebook, Twitter, LinkedIn, Instagram, What's On, and ArtsHub. Supply Nation, Multicultural NSW, Digest, Sydney University and Haymarket Chamber of Commerce also promoted the program through their networks. The City Business team worked closely with industry stakeholders to promote these grants and delivered a dedicated virtual briefing for business intermediaries such as local chambers of commerce, industry organisations and Liquor Accord associations to promote these programs through their channels and networks. Email campaigns were utilised to target interested parties who have applied previously for grants at the City or who have expressed an interest in the City's programs.
- 5. The Community Services Grant Program is open to not-for-profit organisations. For profit organisations are not eligible to apply under this Program.
- 6. Following adoption of the revised Grants and Sponsorship Policy on 22 February 2021, the Festivals and Events Sponsorship (Village and Community) Program is open to appropriately incorporated for-profit organisations and not-for-profit organisations. Six applications were received this round from for-profit organisations and no for-profit organisations are recommended in this report.
- 7. The Matching Grants Program is open to appropriately incorporated for-profit and not-for-profit organisations. Seventeen applications were received this round from for-profit organisations and sole traders and the following three for-profit organisations and sole traders are recommended in this report:
 - (a) Shane Robert Beckham;
 - (b) Kathryn Pollock; and
 - (c) Rave Reviewz Pty Ltd.
- 8. There were a total of 124 grant applications received for social grants. Fifty-one are recommended for funding as detailed in this report.
- 9. It is expected that all successful applicants will work co-operatively with relevant City staff throughout the project they have received funding for.

- 10. All grants and sponsorships are recommended on the condition that any required approvals, permits and development consents are obtained by the applicant. In the current environment this includes but is not limited to, requirements associated with the service of alcohol or food services, consent from the respective landowner(s), and State Planning Legislation and State Government health requirements. Approval must be sought from the City for any relevant development consents and temporary outdoor event activities.
- 11. Park hire requests are not listed in the table of recommendations, as not-for-profit organisations are eligible for free park hire. However, these organisations must pay the \$100 application fee and other related fees and charges, such as electricity and water. Individuals or unincorporated community groups are required to be auspiced by a not-for-profit organisation to be eligible for free park hire. All park hire is subject to availability. For-profit organisations are required to pay park hire fees.
- 12. The City's Grants and Sponsorship Program is highly competitive. Applications that are not recommended have either not scored as highly against the assessment criteria as the recommended applications or have incomplete or insufficient information. The City's Grants and Sponsorship team provides feedback to unsuccessful applicants when requested.
- 13. The assessment process includes advice and recommendations from a suitably qualified assessment panel. The applications are scored against defined criteria for each grant program as well as the integrity of the proposed budget, project plan, partnerships, contributions and connection to the local community and industry sectors. Once recommended applications are approved by Council, a contract is developed, which includes conditions that must be adhered to, and acquitted against.
- 14. In assessing the grant applications, the assessment panels included in their considerations and recommendations:
 - (a) A City of All Social Sustainability Policy;
 - (b) Community Recovery Plan 2020;
 - (c) Creative City Cultural Policy and Action Plan;
 - (d) Economic Development Strategy;
 - (e) Grants and Sponsorship Policy;
 - (f) Environmental Strategy and Action Plan;
 - (g) Sustainable Sydney 2030; and
 - (h) alignment with other core City strategic policies and action plans.
- 15. Assessors consider the cash and in-kind contribution from the applicant and other sources in reviewing applications. Applicants are asked to demonstrate a capacity to match the grant investment with other sources of funding or contribute their own cash resources to the project.
- 16. Applicants are requested to list their project's community partners, confirmed funding sources and the contribution the organisation is making to the project (cash or in-kind) to demonstrate their contribution.

Community Services Grant Program

- 17. The assessment panel for the Community Services Grant Program consisted of City staff from the Indigenous Leadership and Engagement, Social City, Creative City, City Greening and Leisure, City Design and City Business and Safety teams.
- 18. The applications recommended for the Community Services Grant Program are outlined in Attachment A to this report. The applications not recommended are listed in Attachment B to this report.
- 19. Additional funds for the Community Services Grant Program were made available due to an underspend in the Grants and Sponsorship Economic programs this includes the Business Support Place and Industry and Business Support Night Time Diversification grant programs.

Festivals and Events Sponsorship (Village and Community) Program

- 21. The Festivals and Events Sponsorship Program aims to support festivals and events that celebrate, develop and engage the City's communities. The City provides support for festivals and events under two categories: Artform or Village and Community.
- 22. Village and Community festivals and events celebrate the spirit of a community and build opportunities to share its cultural characteristics with a wider public. Events may nurture and amplify the unique characteristics of the city and village precincts, meet the City's broader place-making objectives and/or showcase a local community, including local business.
- 23. The assessment panel for Festivals and Events Sponsorship (Village and Community) consisted of City staff from the City Business and Safety, Grants and Sponsorship, and Social City teams, with specialist input from the City Business and Safety, Indigenous Leadership and Engagement, Social City, Strategy and Communications, Corporate Partnerships, and Venue Management teams.
- 24. The applications recommended for the Festivals and Events Sponsorship (Village and Community) Program are outlined in Attachment C. The applications that are not recommended are listed in Attachment D.
- 25. Additional funds for the Festivals and Events Sponsorship (Village and Community) Program were made available due to an underspend in the Grants and Sponsorship Economic programs - this includes the Business Support - Place and Industry and Business Support - Night Time Diversification grant programs.

Matching Grant Program

- 27. The Matching Grant Program provides matched funding of up to \$10,000 for any projects that improve, enhance, or celebrate the City's Villages. Council approved the development of this program to support identified grassroots community projects by matching with City resources what is contributed in cash or in-kind by the community.
- 28. To be eligible for funding, applications to the Matching Grant Program must demonstrate a matched cash contribution or value-in-kind contribution to the project at least equal to the amount requested from the City.
- 29. The assessment panel for Matching Grants applications consisted of City staff from the City Business and Safety, City Greening and Leisure, Cultural Strategy, Creative City, Grants and Sponsorship, Indigenous Leadership and Engagement, Property Services and Social Policy and Program teams.
- 30. The applications recommended for the Matching Grant Program are outlined in Attachment E to this report. The applications not recommended are listed in Attachment F to this report.

Key Implications

Strategic Alignment - Sustainable Sydney 2030

- 31. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond. It includes 10 strategic directions to guide the future of the City, as well as 10 targets against which to measure progress. This grant is aligned with the following strategic directions and objectives:
 - (a) Direction 2 provides a road map for the City to become A Leading Environmental Performer - the recommended grant projects in this report contribute to the City's endeavours to work with our business and residential communities to reduce greenhouse emissions and potable water use and encourage diversion of waste from landfill across the local government area.
 - (b) Direction 6 Vibrant Local Communities and Economies the recommended grant projects in this report contribute to fostering strong and sustainable local economies.
 - (c) Direction 7 A Cultural and Creative City the recommended grant projects in this report contribute to a city where opportunities for individual creative expression and participation in all its forms are visible, valued, and accessible, and where business and creative opportunities for local artists, creative workers and cultural organisations are supported.

Organisational Impact

32. The grants and sponsorships contract management process will involve key staff across the City of Sydney. Identified staff set contract conditions and performance measures for each approved project, and review project acquittals, which include both narrative and financial reports.

Social / Cultural / Community

33. The City's Grants and Sponsorship Program provides the City with a platform to support cultural, economic, environmental and social initiatives from the communities, and community organisations, within the local area.

Financial Implications

- 34. There are sufficient amounts allocated in the Grants and Sponsorship Social program budget, included in the City's draft operating budget for 2022/23 and future year forward estimates to fund the value of the recommended grants. A total of \$1,619,653 in cash and \$208,797 in revenue foregone/value-in-kind is recommended from the 2022/23 (draft) cash budget, as follows:
 - (a) Community Services Grant Program \$926,888 cash is provided against the draft budget of \$1,686,653 including additional funds of \$48,985 for the Community Services Grant program that were made available due to an underspend in the Grants and Sponsorship Economic programs;
 - (b) Festivals and Events Sponsorship (Village and Community) Program \$592,950 cash is provided against the draft budget of \$1,150,000 including additional funds of \$34,937 for the Festivals and Events Sponsorship (Village and Community) program that were made available due to an underspend in the Grants and Sponsorship Economic programs; and
 - (c) Matching Grant Program \$99,815 cash is provided against the draft budget of \$340,000.
- 35. Additionally, this report includes forward commitments of \$731,824 in cash and \$22,036 revenue foregone/value-in-kind.
- 36. All expenditure that exceeds the nominated budgets for the 2022/23 financial year outlined in the Operational Plan will be offset in full from the overall Grants and Sponsorship Program's budget. These savings have occurred as a result of an underspend in the Grants and Sponsorship Economic programs.

Relevant Legislation

- 37. Section 356 of the Local Government Act 1993 provides that a council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
- 38. Section 356(3)(a) to (d) is satisfied for the purpose of providing grant funding to for profit organisations because:
 - (a) the funding is part of the following programs:
 - (i) Community Services Grant Program;
 - (ii) Festivals and Events Sponsorship (Village and Community) Program; and
 - (iii) Matching Grant Program;
 - (b) the details of these programs were included in Council's adopted operation plan for financial year 2021/22;
 - (c) the program's proposed budgets do not exceed five per cent of Council's proposed income from ordinary rates; and

(d) these programs apply to a significant group of persons within the local government area.

Critical Dates / Time Frames

39. Funding for the Community Services Grants, Festivals and Events Sponsorship (Village and Community) and Matching Grants approved in 2021/22 for activity taking place from 1 July 2022 to 30 June 2023. Contracts will be developed for all successful applications after Council approval to ensure their funding is released in time for projects starting in July.

Public Consultation

- 40. During February and March 2022 three briefing sessions took place where stakeholders were notified about the grants and how to apply:
 - (a) An in-person business collaboration session called Revitalising Sydney was held at Mary's Underground on 22 February 2022. A total of 38 participants, including creative producers, artists, business chambers and local businesses attended this session.
 - (b) An online grant briefing session specifically for Business Chambers was held on 2 March 2022. A total of 17 attendees participated in the session.
 - (c) An online briefing session for general grants enquires was held on 3 March 2022 for potential grant applicants. A total of 173 attendees participated in the session.

Grants and Sponsorship - Knowledge Exchange Sponsorship Program

Summary

The City of Sydney's Grants and Sponsorship Program supports initiatives and projects that build the social, cultural, environmental and economic life of the city and assist in the recovery from the Covid-19 pandemic. To achieve the objectives of the Community Recovery Plan and Sustainable Sydney 2030, genuine partnership between government, business and the community is required.

The provision of grants and sponsorships is a mechanism to further the aims identified in the City's social, cultural, economic and environmental policies. Applications are assessed against these policies and against broad City objectives and plans. In this way, the City and the community act collaboratively to achieve the goals of the Community Recovery Plan and Sustainable Sydney 2030.

The City advertised the Knowledge Exchange Sponsorship Program in the annual Grants and Sponsorship Program for approval in 2021/22 and payment in 2022/23.

For the Knowledge Exchange Sponsorship Program, 43 eligible applications were received. This report recommends a total of 17 grants to a total value of \$507,604 in cash and \$32,315 value-in-kind for payment in the 2022/23 financial year, and commitments of \$95,452 in cash and \$2,211 value-in-kind for payment in the 2023/24 financial year.

On 22 February 2021, Council adopted a revised Grants and Sponsorship Policy. All grants in this report were assessed in accordance with the Grants and Sponsorship Policy, the Grants and Sponsorship Guidelines, the priorities set out in the Community Recovery Plan and various other relevant City strategies and action plans.

All grant recipients will be required to sign a contract, meet specific performance outcomes and acquit their grant. All figures in this report exclude GST.

Recommendation

It is resolved that:

- (A) Council approve the cash and value in kind recommendations for the Knowledge Exchange Sponsorship Program as shown at Attachment A to the subject report;
- (B) Council note the applicants who were not successful in obtaining a cash grant or value in kind for the Knowledge Exchange Sponsorship Program as shown at Attachment B to the subject report;
- (C) Council note that all grants amounts are exclusive of GST;
- (D) authority be delegated to the Chief Executive Officer to negotiate, execute and administer agreements with any organisation approved for a grant or sponsorship under terms consistent with this resolution and the Grants and Sponsorship Policy; and
- (E) authority be delegated to the Chief Executive Officer to correct minor errors to the matters set out in this report, noting that the identity of the recipient will not change, and a CEO Update will be provided to Council advising of any changes made in accordance with this resolution.

Background

- 1. The City of Sydney's Grants and Sponsorship Program supports residents, businesses and not-for-profit organisations to undertake initiatives and projects that build the social, cultural, environmental and economic life of the city.
- 2. On 22 February 2022, the City announced the grants program for approval in 2021/22 and payment in 2022/23 as being open for application on the City's website, with grant applications closing on 11 April 2022.
- 3. Information about the Knowledge Exchange Sponsorship Program (such as application dates, guidelines and eligibility criteria) was made available on the City's website. The City actively promoted the program through Facebook, Twitter, LinkedIn, Instagram, What's On, and ArtsHub. Supply Nation, Multicultural NSW, Digest, Sydney University and Haymarket Chamber of Commerce also promoted the program through their networks. The City Business team worked closely with industry stakeholders to promote these grants and delivered a dedicated virtual briefing for business intermediaries such as local chambers of commerce, industry organisations and Liquor Accord associations to promote these programs through their channels and networks. Email campaigns were utilised to target interested parties who have applied previously for grants at the City or who have expressed an interest in the City's programs.
- 4. The Knowledge Exchange Sponsorship program is open to appropriately incorporated for-profit organisations and partnerships.
- 5. Seventeen applications were received in the Knowledge Exchange Sponsorship program round from for-profit organisations and the following seven for-profit organisations are recommended in this report:
 - (a) Artspay Pty Ltd;
 - (b) Bistro Pty Ltd;
 - (c) Flare Access Pty Ltd;
 - (d) Inspiring Rare Birds Pty Ltd:
 - (e) Jarin Street Pty Ltd:
 - (f) Michelle Tabet Pty Ltd; and
 - (g) Vibelab Asia Pacific Pty Ltd.
- 6. There were a total of 43 grant applications received for the Knowledge Exchange Sponsorship Program. Seventeen are recommended for funding as detailed in this report.
- 7. It is expected that all successful applicants will work co-operatively with relevant City staff throughout the project for which they have received funding.

- 8. All grants and sponsorships are recommended on the condition that any required approvals, permits and development consents are obtained by the applicant. In the current environment this includes but is not limited to, requirements associated with the service of alcohol or food services, consent from the respective landowner(s), and State Planning Legislation and State Government health requirements. Approval must be sought from the City for any relevant development consentsand temporary outdoor event activities.
- 9. Park hire requests are not listed in the table of recommendations, as not-for-profit organisations are eligible for free park hire. However, these organisations must pay the \$100 application fee and other related fees and charges, such as electricity and water. Individuals or unincorporated community groups are required to be auspiced by a not-for-profit organisation to be eligible for free park hire. All park hire is subject to availability. For-profit organisations are required to pay park hire fees.
- 10. The City's Grants and Sponsorship Program is highly competitive. Applications that are not recommended have either not scored as highly against the assessment criteria as the recommended applications or have incomplete or insufficient information. The City's Grants and Sponsorship team provides feedback to unsuccessful applicants when requested.
- 11. The assessment process includes advice and recommendations from a suitably qualified assessment panel. The applications are scored against defined criteria for each grant program as well as the integrity of the proposed budget, project plan, partnerships, contributions and connection to the local community and industry sectors. Once recommended applications are approved by Council, a contract is developed, which includes conditions that must be adhered to, and acquitted against.
- 12. In assessing the grant applications, the assessment panels included in their considerations and recommendations:
 - (a) Community Recovery Plan 2020;
 - (b) Grants and Sponsorship Policy;
 - (c) Sustainable Sydney 2030; and
 - (d) alignment with other core City strategic policies and action plans.
- 13. Assessors consider the cash and in-kind contribution from the applicant and other sources in reviewing applications. Applicants are asked to demonstrate a capacity to match the grant investment with other sources of funding or contribute their own cash resources to the project.
- 14. Applicants are requested to list their project's community partners, confirmed funding sources and the contribution the organisation is making to the project (cash or in-kind) to demonstrate their contribution.

Knowledge Exchange Sponsorship Program

15. The Knowledge Exchange Sponsorship Program supports showcasing local expertise and encourages dialogue on local and global issues.

- 16. Sponsorship includes support for research, strategic initiatives, programs or events that promote the sustainable development of cities; mentorship and networking events that bring people together to learn from each other; tools or guides to communicate best practice; and build skills and expertise within social, cultural, green and business industry sectors.
- 17. The assessment panel for the Knowledge Exchange Sponsorship Program consisted of City staff from the Cultural Projects, Homelessness and Social Strategy teams with additional specialist input from the City Business and Safety, Cultural Strategy, Economic Strategy, Indigenous Leadership and Engagement, Security and Emergency Management, Social Programs, and Sustainability and Resilience Strategy teams.
- 18. The applications recommended for the Knowledge Exchange Sponsorship Program are outlined in Attachment A to this report. The applications not recommended are listed in Attachment B to this report.
- 19. Additional funds for the Knowledge Exchange Program were made available due to an underspend in the Grants and Sponsorship Economic programs this includes the Business Support Place and Industry and Business Support Night Time Diversification grant programs.

Key Implications

Strategic Alignment - Sustainable Sydney 2030

- 21. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond. It includes 10 strategic directions to guide the future of the City, as well as 10 targets against which to measure progress. This grant is aligned with the following strategic directions and objectives:
 - (a) Direction 2 A Leading Environmental Performer the recommended grant projects in this report contribute to the City's endeavours to work with our business and residential communities to reduce greenhouse emissions and potable water use and encourage diversion of waste from landfill across the local government area.
 - (b) Direction 6 Vibrant Local Communities and Economies the recommended grant projects in this report contribute to fostering strong and sustainable local economies.
 - (c) Direction 7 A Cultural and Creative City the recommended grant projects in this report contribute to a city where opportunities for individual creative expression and participation in all its forms are visible, valued, and accessible, and where business and creative opportunities for local artists, creative workers and cultural organisations are supported.

Organisational Impact

22. The grants and sponsorships contract management process will involve key staff across the City of Sydney. Identified staff set contract conditions and performance measures for each approved project, and review project acquittals, which include both narrative and financial reports.

Social / Cultural / Community / Environmental and Economic

23. The City's Grants and Sponsorship Program provides the City with a platform to support cultural, economic, environmental and social initiatives from the communities, and community organisations, within the local area.

Financial Implications

- 24. There are sufficient amounts allocated in the Knowledge Exchange Sponsorship program budget, included in the City's draft operating budget for 2022/23 and future year forward estimates to fund the value of the recommended grants. A total of \$507,604 in cash and \$32,315 in value-in-kind is recommended from the 2022/23 (draft) cash budget.
- 25. Additionally, this report includes forward commitments for 2023/24 of \$95,452 in cash and \$2,211 value-in-kind.
- 26. All expenditure that exceeds the nominated budgets for the 2022/23 financial year outlined in the Operational Plan will be offset in full from the overall Grants and Sponsorship Program's budget. These savings have occurred as a result of an underspend in the Grants and Sponsorship Economic programs.

Relevant Legislation

- 27. Section 356 of the Local Government Act 1993 provides that a council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
- 28. Section 356(3)(a) to (d) is satisfied for the purpose of providing grant funding to for profit organisations because:
 - (a) the funding is part of the Knowledge Exchange Sponsorship Program;
 - (b) the details of the program were included in Council's adoptedoperational plan for financial year 2021/22;
 - (c) the program's proposed budgets do not exceed five per cent of Council's proposed income from ordinary rates; and
 - (d) these programs apply to a significant group of persons within the local government area.

Critical Dates / Time Frames

29. Funding for the Knowledge Exchange Sponsorship Program is approved in 2021/22 for activity taking place from 1 July 2022 to 30 June 2023. Contracts will be developed for all successful applications after Council approval to ensure their funding is released in time for projects starting in July.

Public Consultation

- 30. During February and March 2022 three briefing sessions took place where stakeholders were notified about the grants and how to apply:
 - (a) An in-person business collaboration session called Revitalising Sydney was held at Mary's Underground on 22 February 2022. A total of 38 participants, including creative producers, artists, business chambers and local businesses attended this session.
 - (b) An online grant briefing session specifically for Business Chambers was held on 2 March 2022. A total of 17 attendees participated in the session.
 - (c) An online briefing session for general grants enquires was held on 3 March 2022 for potential grant applicants. A total of 173 attendees participated in the session.

Grants and Sponsorship - Accommodation Grant Program - Annual Performance Review and Lease Renewals 2022

File No: \$117676

Summary

The Accommodation Grant Program (the Program) supports community, cultural, economic and sustainability focused organisations by providing accommodation in City owned buildings within the property portfolio at nil or below market rent.

Accommodation Grant recipients are organisations that provide services that meet the needs identified in Sustainable Sydney 2030 and the City's strategic plans and policies. Demand for properties remains strong, with more than 627 organisations currently on a notification list for future properties.

For the 2021 calendar year annual review, there were 74 leases held by 67 organisations located across 53 City properties managed under the Program. These tenancies were approved by Council as Accommodation Grants. Recipients of Accommodation Grants enter leases or licences with the City for a fixed term of appropriate length, usually five years, subject to an annual performance review. There are a number of organisations that hold multiple leases through this grant program.

Each year, the City coordinates the annual performance review with the Accommodation Grant recipients (lease holders) to review their performance against the criteria in their lease or licence agreements. A rating system is used to evaluate the information received and assess the performance of the organisations against the criteria set, in return for subsidised accommodation. This report outlines the outcomes of the annual performance review for the 2021 calendar year.

For the 2021 assessment period, 74 lease holders were in the Accommodation Grants program and 73 were requested to complete an annual performance review. One lease holder was not required to complete a review as they have not been in the program for a full 12 months and will submit a review next year.

Of the 73 lease holders requested to complete an annual performance review, one lease holder has not been assessed as they will remain in holdover until the City is able to fulfil its Crown land management requirements over the associated land, and another four lease holders have or will be vacating the program by 30 June 2022.

This report is recommending Council note the continuation of the 68 lease holders who were reviewed, have met their performance criteria and will be continuing in the program.

This report includes a recommendation to approve a new subsidy for the Australian Design Centre at 101-111 and 113-115 William Street Darlinghurst for their previously approved five year lease.

This report also notes properties that have been vacated.

All figures in this report and its attachments are exclusive of GST.

Recommendation

It is resolved that:

- (A) Council note the continuation of the current Accommodation Grant leases and licences for the 68 lease holders that have satisfactorily completed their annual performance review for the 2021 calendar year and are continuing in the Program;
- (B) Council note the Museum of Chinese in Australia Ltd at 744 George Street was not required to complete an annual performance review and are continuing in the Program;
- (C) Council note the City has not provided an annual rating for The Roman Catholic Church for The Archdiocese of Sydney (Catholic Care) for the property at 1b Cathedral Street, Woolloomooloo as the lease is currently on monthly holdover;
- (D) Council approve the new subsidy and grant level for the Australian Design Centre at 101-111 and 113-115 William Street, Darlinghurst for their previously approved five year lease for the period 1 July 2022 to 22 March 2026 on the following rental subsidy:

Attachment A. Annual Performance Review Ratings

Background

- 1. For the 2021 calendar year annual review, there were 74 leases held by 67 organisations located across 53 City properties managed under the Program. Of these, 73 lease holders were requested to complete an annual performance review.
- 2. The Museum of Chinese in Australia Ltd was not required to complete a review as they have not been in the program for a full 12 months and will submit a review next year.
- 3. Four lease holders have or will be vacating the Program by 30 June 2022 and as a result the outcome of their performance reviews have not been included in this report.
- 4. As at 30 June 2022, the Accommodation Grant Program will make available 70 spaces for 63 organisations in 50 buildings. The total cost of the Program in revenue forgone for the 2022/23 financial year is estimated at \$7.5 million.
- 5. The terms and conditions of the agreement between each lease holder and the City are detailed in a lease or licence, which also sets out specific key performance criteria and performance measures. Lease holders are reviewed every 12 months against these criteria and measures. Based on these reviews, the following options exist: continuation; improvement; termination; or a variation to the terms of the existing lease or licence.

Outcomes of 2021 Annual Performance Review

- 6. The annual performance review of Accommodation Grant recipients was undertaken between January 2022 and March 2022 and is based on the 2021 calendar year.
- 7. Lease holders submitted their annual performance reviews online. City staff members evaluated the submissions provided and the lease holders' overall performance in 2021 against the criteria contained in the respective lease or license. Final evaluations were agreed upon during assessment meetings using the following ratings:
 - A meeting or exceeding performance criteria;
 - A/B meeting the majority of performance criteria;
 - B not meeting performance criteria, on notice (one year to improve performance); or
 - C not meeting expectations after one year, leases to be terminated.
- 8. The 68 lease holders who participated in the annual review process have been rated 'A' or 'A/B' against their performance criteria and will be continuing in the Program (see Attachment A).
- 9. The City has not provided an annual rating for The Roman Catholic Church for The Archdiocese of Sydney (Catholic Care) for the property at 1b Cathedral Street, Woolloomooloo. This lease is on holdover until Crown land management requirements over the associated land are resolved. Once this has been resolved the City will review the use of the property and determine ongoing use.

10. It is noted that City staff will work closely with six lease holders who were rated A/B over the next 12 months; Gay & Lesbian Rights Lobby, Geoff Holmes trading as Glebe Music Project, Kil.n.it Experimental Ceramics Studio (both tenancies), The Bower Reuse & Repair Centre Co and Tribal Warrior Association Incorporated. Several areas for improvement have been identified with these lease holders, such as proactive and regular communication, establishing expectations around reporting and updating performance criteria.

Properties vacated

- 11. The tenancy at 12a Dadley Street, Alexandria was vacated by Australian Unity in May 2022. After a rental subsidy review in 2021 which took into consideration the organisation's financial position, the organisation opted not to enter into a new lease. Office space will be provided at an alternate organisation's premises. This will not impact outreach Aboriginal Homecare services provided in the local community.
- 12. The tenancy at Suite 1, Benledi House, 186 Glebe Point Road, Glebe will be vacated by Babana Aboriginal Men's Group Incorporated effective 30 June 2022. During the lockdown period, Babana Aboriginal Men's Group Incorporated adapted their services to continue to support their network and the community. Following lockdown, Babana Aboriginal Men's Group Incorporated have continued operating with flexible workplace arrangements which has reduced their need for the property at Benledi House, Glebe. Moving forward they will utilise office space with Tribal Warrior, a local service in Redfern, to provide complimentary and collaborative services and programs.
- 13. Tenancy one, 247 Oxford Street, Paddington became vacant in May 2022. The City will review the use of this property to determine ongoing use.
- 14. The tenancy at Abraham Mott Activity Centre, 2 Watson Road, Millers Point was vacated by Sydney School of Arts and Humanities in June 2021 as the organisation had moved most of their workshops online and no longer require use of this property. The space is currently being used in conjunction with the full time Covid-19 testing clinic established in December 2021 and expected to continue to at least 30 June 2022.

Australian Design Centre

15. Australian Design Centre (ADC) is currently in Year 2 of a five year lease for 101-111 and 113-115 William Street, Darlinghurst - expiring 22 March 2026. The lease was approved to be issued by Council in December 2019. However in March 2021, due to the impacts of Covid-19, Council approved to increase the Accommodation Grants Program lease subsidy of several cultural and community organisations. Australian Design Centre was one of these organisations whose subsidy was increased at this point. At that time Australian Design Centre was impacted by reduced government funding; reduced opportunity for self-generated income; and a greater demand for the organisation's services and support.

- 16. Despite this subsidy increase, in early 2022, Australian Design Centre reported continued and significant flow on effects from Covid-19. They have been impacted by cancellation of events; the requirement to continue to invest in digital experiences; much lower audience numbers and loss of funding. Australian Design Centre has therefore requested additional rental subsidy to support its efforts to rebuild the organisation and operations. Increased subsidy to the organisation will allow it to recover momentum and rebuild with new opportunities for creative practitioners. It plans to undertake a minor refurbishment of its gallery spaces to increase exhibition opportunities; developing First Nations programs and develop additional programs and audiences.
- 17. The City recognises the deep impacts of two years of disruption from the pandemic, and that issues continue to be felt across the cultural sector. To support its recovery efforts the subsidy previously approved for the Australian Design Centre has been reviewed and a higher grant level is recommended.
- 18. The below table shows the proposed subsidy recommendation and notes the total impact on City revenue is \$174,069 across 2022/23, 2023/24, 2024/25 and 2025/26.

Key Implications

Strategic Alignment - Sustainable Sydney 2030

- 19. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond. It includes 10 strategic directions to guide the future of the City, as well as 10 targets against which to measure progress. This report is aligned with the following strategic directions and objectives:
 - (a) Direction 6 Vibrant Local Communities and Economies the provision of accommodation to a varied group of community and cultural organisations contributes to the diverse range of services and support the City provides for our community. The diversity of these groups contributes to the vibrancy of the City's villages and the communities within them.
 - (b) Direction 7 A Cultural and Creative City approximately one third of the Accommodation Grant lease holders are cultural or arts organisations. These organisations support cultural development through the support of artists, and the delivery of culturally stimulating activities that engage our communities.

Social / Cultural / Community

20. The community and cultural organisations that are part of the Accommodation Grants Program make an invaluable contribution to our communities through the development and management of services, activities and programs.

Financial Implications

21. Based on the current list of Accommodation Grant recipients the total value of the Accommodation Grant Program in the 2022/23 financial year is estimated at \$7.5 million in revenue foregone, compared to market value rent.

Relevant Legislation

- 22. Section 356 of the Local Government Act 1993 provides that a council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
- 23. Section 356(3)(a) to (d) is satisfied for the purpose of providing grant funding to for profit organisations because:
 - (a) the funding is part of the Accommodation Grant Program;
 - (b) the details of these programs were included in Council's adopted operational plan for financial year 2021/22;
 - (c) the program's proposed budget does not exceed five per cent of Council's proposed income from ordinary rates; and
 - (d) this program applies to a significant group of persons within the local government area.

Critical Dates / Time Frames

24. Expiry dates for the leases recommended in this report are from 1 July 2022 to 22 March 2026.

Grants and Sponsorship - Ad Hoc Festivals and Events Sponsorship - Rabbitohs Grand Final Live Site and Fan Days

Summary

Souths Cares PBI Ltd ("Souths Cares") is an independent not-for-profit public benevolent institution affiliated with the South Sydney District Rugby League Football Club - The Rabbitohs. It was established to support the local community and address social needs across the South Sydney region. Its charter is to support disadvantaged, marginalised and Indigenous youth and their families with a specific focus on education, training, health and employment.

The local community support and popularity of the Rabbitohs is strong, and the club has a long-standing relationship with the Aboriginal and Torres Strait Islander community in Redfern. The Rabbitohs' emblem and the red and green colours on the club's jersey are symbolic to the Aboriginal and Torres Strait Islander community and widely recognised throughout Australia. In 2008, the club was given recognition as a National Trust Community Icon for their historical, sporting, social and cultural significance.

Since 2012, the Rabbitohs have made it as far as the NRL preliminary finals seven times, won the premiership in 2014 and were runners-up in 2021. They remain a strong and competitive club with good prospects for future seasons.

In 2019, with the potential for the Rabbitohs to make the finals, Souths Cares recognised the importance of providing fans an opportunity to be involved in the NRL Grand Final, and requested support from the City for a series of activities to showcase the Grand Final itself if the Rabbitohs were successful in qualifying and to celebrate their success with the local community if they were crowned champions. This included a Grand Final Day Live Site, and Trophy Presentation at Redfern Oval, and Champions Parade through Redfern.

In response to the Souths Cares request, Council approved a cash sponsorship and venue hire fee waiver for three years (2019, 2020, and 2021) subject to the Rabbitohs qualifying for the Grand Final in the relevant year.

This report seeks Council's approval to extend support to the Rabbitohs for a further three year period on the same terms, with the addition of waiving of fees for banner pole hire, banner manufacture, installation/dismantlement and associated banner fees.

Recommendation

It is resolved that:

- (A) Council approve cash sponsorship of \$60,000 (excluding GST) per year for three years and community venue hire value in kind of \$1,000 per year for three years to Souths Cares PBI Ltd for Grand Final qualification and celebratory activities in 2022, 2023 and 2024, subject to the Rabbitohs qualifying for the Grand Final in the relevant year;
- (B) in line with the City's adopted Revenue Policy, allowing for the waiving of fees in accordance with a decision by Council to grant financial assistance, that Council approve the design and manufacture of 60 Rabbitohs themed banners to the value of \$6,000, and waive street banner hire fee to the value of \$8,000 per annum to Souths Cares PBI Ltd, for the installation and dismantling of street banners subject to the Rabbitohs qualifying for the Grand Final in the relevant year;
- (C) Council note that the 2022/23 funds, if required, will be drawn from the General Contingency Fund, and should funds be required for future financial years, they will be drawn from the General Contingency Fund in the relevant year; and
- (D) authority be delegated to the Chief Executive Officer to negotiate, enter into and administer a grant agreement with Souths Cares PBI Ltd to give effect to this resolution.

Background

- 1. The South Sydney District Rugby League Football Club (the Club) was formed at a meeting on 17 January 1908 at Redfern Town Hall.
- 2. The local community support and popularity of the Rabbitohs is strong, and the Club has a long-standing relationship with the Aboriginal and Torres Strait Islander community in Redfern. The Rabbitohs' emblem and the red and green colours on the club's jersey are symbolic to the Aboriginal and Torres Strait Islander community and widely recognised throughout Australia.
- 3. Souths Cares PBI Limited (Souths Cares) continues to support the local community with programs such as a Deadly Youth Mentoring Program, Indigenous oral health program, and other projects supporting local students and young people in health, wellbeing, and employment skills training. The Club also provides important sports opportunities for young people from the local area and surrounds, with the Pathways team and Women's team developing junior and women players to compete in rugby league across Sydney.
- 4. On 12 November 2000, an estimated 80,000 people marched from Redfern to Sydney Town Hall to protest against the Club's expulsion from the NRL. Re-admission to the NRL was granted in 2002, and in 2008, the Club was given recognition as a National Trust Community Icon for their historical, sporting, social and cultural significance.
- 5. In 2014, South Sydney Football Club organised a Grand Final live site at Redfern Oval, however, the live site was for Rabbitohs Members only and cost \$10 to enter. This meant that members of the public who supported the Rabbitohs but who were not club members could not enter, and as such, members of the community went to surrounding pubs to watch the match.
- 6. In 2019, Souths Cares recognised the importance of providing fans an opportunity to be involved in the NRL Grand Final, and requested support from the City for a series of activities to showcase the Grand Final if the Rabbitohs were successful in qualifying and to celebrate their success with the local community if they were crowned champions.
- 7. Since the City agreed to provide Souths Cares support in 2019, the Rabbitohs have reached the NRL Grand Final once in 2021. Due to Covid restrictions, a live site was not able to proceed and the Rabbitohs were unsuccessful in winning the grand final. Therefore no funds were expended under the previous grant..

8. The following three events have been proposed in the event that the Rabbitohs are successful in making the NRL Grand Final in 2022, 2023 and 2024:

- 9. Souths Cares previously estimated the cost for all activities at \$97,925. A high proportion of these costs are associated with the Live Site activities on Grand Final Day and the infrastructure provided for this would then also be used in situ for the Trophy Presentation pending the outcome of the Final. In the event that the Rabbitohs do make the grand final, Souths Cares would work closely with an event management company to organise and conduct the proposed activities.
- 10. Souths Cares plan to provide free entry to the live site and other events, giving fans and the local community an accessible opportunity to enjoy the game in the local area. The live site will include a large screen for viewing the game, on site food and beverage offerings including a licensed area and activities such as a drill and skill clinic. Live site attendance is expected to be 4,000 people, with half estimated to come from outside the local area. As the grand final is usually played on the October Long Weekend with the Monday being a public holiday and the following days when the parade is planned being school holidays, young people from the community will have the opportunity to attend.
- 11. In the event that the Rabbitohs reach the preliminary finals (usually a week before the grand final) and are successful therefore securing a place in the grand final, the City will install 60 Rabbitohs-themed banners in Redfern Street and South Dowling Street. These will be installed the first available working day after the preliminary final and will stay up for the duration of the week leading up to the grand final. In the event that the Rabbitohs win the grand final the banners will remain in-situ for an additional week. If they are unsuccessful, the banners will be removed the first available working day after the grand final.
- 12. A further three-year in principle sponsorship, contingent each year on the Rabbitohs making the Grand Final in any specific year, would allow the City and Souths Cares to better plan and budget for potential Grand Final events in 2022, 2023 and 2024.

- 13. The Festivals and Events Sponsorship Program aims to support festivals and events that celebrate, develop and engage the City's communities. The City provides support for festivals and events under two categories: Artform or Village and Community.
- 14. Village and Community festivals and events celebrate the spirit of a community and build opportunities to share its cultural characteristics with a wider public. Events may nurture and amplify the unique characteristics of the city and village precincts, meet the City's broader place-making objectives and/or showcase a local community, including local business.

Key Implications

Strategic Alignment - Sustainable Sydney 2030

- 15. Sustainable Sydney 2030 is a vision for the sustainable development of the City to 2030 and beyond. It includes 10 strategic directions to guide the future of the City, as well as 10 targets against which to measure progress. This report is aligned with the following strategic directions and objectives:
 - (a) Direction 6 Vibrant Local Communities and Economies Supporting the Rabbitohs reflects the deep-held passions of large portions of the local community and will attract not only locals, but also persons from outside who are drawn to the atmosphere of the events.
 - (b) Direction 7 A Cultural and Creative City Supporting the Rabbitohs reflects the cultural significance that Rugby League and sport in general plays in our community.

Organisational Impact

16. Coordination of the events will involve key staff across the City of Sydney including the Outdoor Events Team, Traffic Management Team, Cleansing & Waste, City Greening & Leisure, as well as the Grants Team who will be required to provide assessment and oversight of the program.

Risks

17. Not supporting the event financially would mean that Souths Cares would be unlikely to be able to deliver the event, or would have to outlay significant costs which would likely result in financial hardship. If the City did not support the event, or chose not to install banners, there is likely to be significant negative community feedback as was the case in 2021 in response to what the community felt was a lack of an appropriate level of banner theming and decoration.

Social / Cultural / Community

18. The benefits to the community are the opportunity to participate in the atmosphere of the grant final amongst the community and without financial constraints, and in the event that the Rabbitohs win, it also provides the community opportunity to celebrate the victory. There is a social and cultural benefit to the community, bringing all demographics together under the banner of sport, reflecting the deep social and cultural connection that the community, especially to the Aboriginal and Torres Strait Islander community, has with the club.

19. Other community benefits are that the event would receive significant publicity, showcasing the Redfern area and community and positively contributing further to its reputation and village attractiveness.

Environmental

20. There are no significant environmental impacts. The events would be required to comply with the City's Event Guidelines which includes that the organiser comply with sustainable event practices and address issues of waste management produced by their event through a detailed waste management plan.

Economic

- 21. Businesses engaged by Souths Cares to facilitate the three events would likely include an event management company, audio-visual providers, event infrastructure providers, food vendors and food and beverage suppliers, security and traffic management services, marketing and promotional services, and temporary event staff. Given Souths Cares existing community relationships and sponsors, many of these businesses would likely come from the local area.
- 22. Additionally, due to the influx of people on event days, local businesses are likely to benefit from incremental patronage both before / after the events.

Financial Implications

- 23. A total of \$60,000 in cash, \$1,000 in community venue hire value-in-kind and \$8,000 banner pole hire value-in-kind, and \$6,000 banner manufacture costs is recommended for allocation from the 2022/23 General Contingency Budget.
- 24. Commitments of \$60,000 cash and \$9,000 value-in-kind will, if required, be drawn from the General Contingency for the 2023/24, and 2024/25 financial years.
- 25. Elaborating on the costs for banners, the \$8,000 annual cost covers two week pole hire for up to 60 banners (value of \$2,880 which is revenue foregone and no hard cost to the City). The remaining \$7,120 are hard costs for installation / dismantlement, washing and storage and only be incurred in the event that the Rabbitohs make the grand final and the banners are installed. The \$6,000 cost for banner manufacturing would be incurred once every three years to replace the banners (or on an as-needs basis).

Relevant Legislation

- 26. Section 356 of the Local Government Act 1993 provides that a council may, in accordance with a resolution of the council, contribute money or otherwise grant financial assistance to persons for the purpose of exercising its functions.
- 27. As Souths Cares PBI Ltd is a not-for-profit, public notification prior to making this grant is not required.

Critical Dates / Time Frames

- 28. The 2022 NRL Grand Final is currently scheduled to be held on the evening of Sunday 2 October 2022. If successful in qualifying the proposed Rabbitohs Grand Final event dates are:
 - Banner installation Monday 26 September 2022;
 - Live site Sunday 2 October 2022;
 - Trophy presentation day Monday 3 October 2022;
 - Parade in Redfern Tuesday 4 or Wednesday 5 October 2022; and
 - Banner dismantlement Monday 10 October 2022.

The above dates may be subject to change.

29. Dates for future years of the grant will be established based on the dates of competition as determined by the NRL.

Public Consultation

30. Consultation has been undertaken with Souths Cares.
