## Speeding Cars in Wellington Street, Waterloo

An email has been received by a resident in Wellington Street, Waterloo raising concerns of vehicles speeding and driving recklessly. He noted that this occurs from motorists travelling in both eastern and western directions. This motorist behaviour appears to be the result of motorist over accelerating eastbound out of the traffic lights at Elizabeth Street, or over accelerating Westbound towards the traffic lights.

The latter appears to often be in an attempt to avoid the red light at the Elizabeth/Wellington Street traffic lights. My concern is for the risk this poses to pedestrians.

South Sydney PAC advised that they would monitor this location..

#### Recommendations

## **Background**

Sydney Trains has applied for the temporary road closure of Eddy Avenue, Haymarket, between Elizabeth Street and Pitt Street (six lanes), between 10pm to 5am each night from 31 March 2023 to 13 April 2023.

#### Comments

The proposed temporary road closure is required to carry out remediation works to the light bridge over Eddy Avenue. The works and the temporary road closure will take place during the planned shutdown of the Inner West Light Rail.

The Applicant has provided a site-specific Traffic Guidance Scheme that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closure.

There are currently no other approved temporary road closures proposed to take place during the same time in this area.

The temporary road closure will not affect any other properties as local access will be provided at all times and alternative access routes are available nearby.

A Traffic Management Plan (TMP) for the temporary road closure was approved by Transport for NSW.

#### Consultation

The Applicant will be required to notify affected stakeholders as stipulated in Schedule B.

## **Financial**

All costs associated with the proposed closures will be borne by the applicant.
