Streets account for 23 per cent of the total local government area (LGA). The target for streets as a collective land use area is 39 per cent green cover with a minimum of 34 percent canopy cover. To achieve the overall LGA targets a variety of measures are defined in Action 1 of the Greening Sydney Strategy. The City has committed to develop policies, programs, and projects to increase the number and type of street gardens, increase the number and type of inroad plantings, plant more street trees, and ensure the largest tree species appropriate for the space is planted.

The planting of trees within the road pavement area is an opportunity to increase tree canopy within the street network above that provided by typical planting within the verge. Planting in the roadway provides a range of benefits including traffic calming by narrowing roadway down and reducing speed, opportunity to install trees clear of overhead services, and the maximised shading of large areas of hardstand.

As part of this strategy implementation, the proposal to install two raised medians strips in Walker Street, Redfern will provide space for planting of trees and general landscaping in the road.

The Alexandria Pedestrian Cycling and Traffic Calming (PCTC) Plan adopted by Council in 2023 includes a proposal to install a Raised Pedestrian Crossings in Renwick Street and footpath widening in Lyne Street at Dadley Street.

  - 55.9 metres and 106.4 metres;
  - 114.1 metres and 120 metres; and

- (E) The allocation of kerbside restrictions as yellow "No Stopping" line as follows:
  - On northern side of Rose Valley Way between the following points east of George Julius Avenue;
    - 103 metres and 107.5 metres; and
    - 114.6 metres and 120 metres.
  - On southern side of Rose Valley Way between the points 102 metres and 120.5 metres, east of George Julius Avenue.
  - On western side of Defries Avenue between the following points north of Epsom Road;
    - 56.4 metres and 61.1 metres;
    - 102.3 metres and 147.1 metres; and
    - 216 metres and 220 metres.
  - On eastern side of Defries Avenue between the following points north of Epsom Road;
    - 39.1 metres and 51.4 metres;
    - 55.9 metres and 60.7 metres;

- 102.1 metres and 140 metres; and
- Around the temporary cul-de-sac in Defries Avenue both north and south of Rose Valley Way.

(F) The allocation of kerbside restrictions as "2P 8am-10pm" as follows:

- On northern side of Rose Valley Way between the points 107.5 metres and 114.6 metres, east of George Julius Avue.
- On western side of Defries Avenue between the following points north of Epsom Road
  - 61.1 metres and 101.8 metres; and
  - 147.1 metres and 213.9 metres.
- On eastern side of Defries Avenue between the following points north of Epsom Road
  - 60.7 metres and 102.1 metres; and
  - 140 metres and 212.9 metres.

## **Comments**

**Background**

The City supports the use of share bikes as part of a safe, sustainable and efficient urban transport system. They provide a useful opportunity for people to try riding in our area and to incorporate riding into their daily travel.

Between January and November 2024, there were over 1,500,000 share bike trips in the City's LGA, averaging over 153,000 trips per month – or 5,000 trips a day.

With the popularity of share bikes, we have also seen a significant rise in the number of share bikes deployed, drastically increasing from 328 in January 2022 to 4,500 in May 2024.

The City have no control over the number of operators in our area, or the number of bikes they deploy. Recently we have received requests that share bike parking be placed on the road, to limit their impact on footpath amenity.

At present, share bikes are often parked on the footpath and in other areas with high levels of walking activity, and sometimes highly contested public domain. To maintain sufficient footpath space for walking, it is preferable to park share bikes on the carriageway - by reallocating road space needs to free up space for the parking of share bikes (and other shared or private micro-mobility).

Reallocation of road space for the parking of shared micromobility vehicles has been widely adopted in leading cities around the world. Most notably in London, UK where they have found that



locating share bike parking in the road has led to less issues in regard to parking compliance and obstructions. Having parking on the footpath leads to more conflict and increases cycling on the footpath.

Share bike users will be directed to park appropriately through targeted share bike operator education. Share bike operators will be monitoring their bikes within the City of Sydney area. If bikes are in a dangerous place, the operators will make arrangements to move them.

Operators provide clear contact details on each share bike so that members of the public or motorists can contact them to move the bicycles out of the traffic lane or when their vehicles are damaged.

Share bike operators have 3rd party insurance and in the instance that a share bike causes damage to a parked car, the operators insurance covers these costs (on a case-by-case basis).

### Comments

Between January and November 2024, over 5,000 share bike trips started or ended on this section of Ultimo Road. An additional 14,000 trips began on nearby streets including Thomas Street, Quay Street and George Street during the same period.

The high number of share bike trips made to and from this location make it a priority to have a bicycle parking area off the footpath. The installation of on-street bicycle parking will mitigate pedestrian conflicts and improve amenity by reducing congestion in the footpath area.

This section of Ultimo Road is one way travelling south-west bound, with large unobstructed sight lines and exceedingly low traffic volumes and speed. Given that the height of parked bikes is approximately 1.2 metres high, sight distance is not expected to be impacted.

The location and layout of the proposed "P Bicycles Only" area is shown in attachment 1. The kerb space on the south side of Ultimo Road, west of Thomas Street, where the changes are proposed is currently signposted as "No Stopping". The "No Stopping" distance is 20 metres long. It is proposed to reallocate 10m of this section of "No Stopping" distance to "P Bicycles Only" to encourage shared bike users to park their bikes on the road rather than the footpath. The proposed space has a width of 3.1m, allowing plenty of additional room and reducing the likelihood of bikes falling into the traffic lane.

The City will install a precast concrete separator (1.5m x 0.8m), line marking and appropriate signage (see attachment 1) to clearly delineate and safely protect bike riders and the bikes in the bicycle parking area.

If endorsed, we will review the space 6 months after implementation to determine how effective it is. During this time we will request for Rangers to monitor the spaces regularly and contact bike share operators to move the bicycles when required.

### Consultation

The City will notify the local residents and businesses before implementing the parking changes.

### Financial

Funds are available in the current budget.

## **Pedestrian Representative**

The Pedestrian Representative has requested an update from TfNSW on the following Items raised in the May LPCTCC meeting:

### **Area of Automated Signals on Pedestrian Crossings within Central Sydney post Covid**

The area that this was reduced to after the Covid pandemic excludes several areas that have a very high pedestrian activity where the expectation of most walkers and (especially tourists) is to be able to cross intersections in parallel with the direction of the car traffic.

Specifically, the area around UTS and Broadway as well as the length of high streets such as Crown Street and Glebe Point Road where the foot traffic is often comprised of students and visitors in transit who may not be aware that they need to push a button to legally get permission to cross a street.

Particularly all four (relatively narrow) corners at Harris Street and Broadway (the intersection of two state roads) are at times very crowded with students and if no-one presses the button the behaviour of the milling crowds could be unpredictable.

Pedestrians should be able to cross in all the areas of high pedestrian activity throughout the area that they were able to in Covid without fear of cars turning into them and without having to stop walking for a full cycle in order to press the button and request permission.

TfNSW advised that the pedestrian crossing signal at the corner of Harris Street and Broadway were updated to automated signals. TfNSW advised they will generally automate the pedestrian signals if the pedestrian button is activated in at least 85% of all cycles. TfNSW has requested the pedestrian representative to provide them a list of specific sites to be investigated for the automated pedestrian signals.

Reversal of footpath changes in several streets dating from Light Rail Construction and Wentworth Avenue changes. - [14 March 2024 meeting](#) (item 34)

The pedestrian representative asked for an update on footpath widenings where TfNSW had agreed to reverse a number of traffic changes and footpath reductions once the Light Rail Construction was complete - on Market St, Wentworth Av, Goulburn St and Pitt Street - Ref. [LPCTCC minutes from 21 October 2015](#) , [18 November 2015 meeting](#) and [20 April 2016 meeting](#) ).

The pedestrian representative asked if these are scheduled to be carried out. Given that the Metro is now operational in four new stations in the city, there is even more reason to improve pedestrian amenity with wider footpaths in all these areas.

TfNSW and the City will provide an update at a future Committee meeting.

### **Update on 40km/h and 30km/h Speed Zones**

The pedestrian representative requested an update on the rollout of 40km/h zones and whether 30km/h are being considered in the City of Sydney area.

City staff advised that the rollout of 40km/h signs and markings on local and regional roads recommenced in November, and is expected to be completed by the end of November.

TfNSW advised that investigations for 30km/h zones are ongoing.
