Item 1

Confirmation of Minutes

Moved by Councillor Gannon, seconded by Councillor Ellsmore -

Item 2

Statement of Ethical Obligations and Disclosures of Interest

Councillor Olly Arkins made the following disclosures:

- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that they work
 closely with Music NSW in their role as Managing Director of the Australian Festival
 Association as peak bodies in the music industry. Councillor Arkins considers that this nonpecuniary conflict of interest is not significant and does not require further action in the
 circumstances, as they have had no contact with them about this item.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that the Nighttime Industries Association is actively involved in campaigning for a better policy setting for nightlife and creative industries, and they work together in the Councillor's role as Managing Director of the Australian Festival Association. Councillor Arkins considers that this nonpecuniary conflict of interest is not significant and does not require further action in the circumstances, as they have had no contact with them about this item.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that Green Music Australia is an active organisation in the Australian music industry and Councillor Arkins works closely with them in their role as Managing Director of the Australian Festival Association. Councillor Arkins considers that this non-pecuniary conflict of interest is not significant and does not require further action in the circumstances, as they have had no contact with them about this item.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that they have known Eamon Waterford, CEO of the Committee for Sydney Inc, for a number of years and regularly attends events they organise. Councillor Arkins considers that this non-pecuniary conflict of interest is not significant and does not require further action in the circumstances, as they have had no contact with them about this item.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that Savanna Peake
 is a staff member for Councillor Arkin's fellow Labor Councillor, and currently a board
 member of the Pride Business Association (NSW). She was not aware that this matter was
 coming before Council. Councillor Arkins considers that this non-pecuniary conflict of interest
 is not significant and does not require further action in the circumstances as they have had no
 contact with Savanna or anyone from Pride Business Association about this item.

Councillor Lyndon Gannon disclosed a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he as social relationships with members of the Board (Jarrod Lomas and Luke Mayna) of Pride Business Association. Councillor Gannon considers that this non-pecuniary conflict of interest is not significant and does not require further action in the circumstances because he did not know that they were applying for the grant, and he has not discussed this with them.

Councillor Zann Maxwell made the following disclosures:

a significant, non-pecuniary interest in Item 3 on the agenda, in that Jarrod Lomas is a
personal friend and President of Pride Business Association. Councillor Maxwell is himself a
member of the Pride Business Association, and his staff member, Savanna Peake, is
currently a Board Director of this organisation. Savanna was unaware this item was coming to
Council, and Councillor Maxwell has not discussed this item with board members of the Pride
Business Association.

Councillor Maxwell stated he would not be voting on this matter.

• a significant, non-pecuniary interest in Item 3 on the agenda, in that the Committee for Sydney has applied for grant funding in this round and been listed as recommended for funding. Councillor Maxwell may have a role in the assistance of the delivery of this initiative in collaboration with the Committee for Sydney.

Councillor Maxwell stated he would not be voting on this matter.

Councillor Jess Miller disclosed a less than significant, non-pecuniary interest in Item 3 on the agenda, in that she is familiar with Michell Tabet and with Start Some Good. Councillor Miller considers that this non-pecuniary conflict of interest is not significant and does not require further action in the circumstances because she has not discussed this grant with either person.

Councillor Adam Worling made the following disclosures:

- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with the CEO and the board of the Australian Fashion Council.
 Councillor Worling considers that this non-pecuniary conflict of interest is not significant and
 does not require further action in the circumstances because details of this or any grant have
 never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with Ainsley Simpson, the CEO of Clothing Stewardship Australia
 (Seamless). Councillor Worling considers that this non-pecuniary conflict of interest is not
 significant and does not require further action in the circumstances because details of this or
 any grant have never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with Lorraine Locke, the grants writer and manager of the
 Darlinghurst Business Partnerships. Councillor Worling considers that this non-pecuniary
 conflict of interest is not significant and does not require further action in the circumstances
 because details of this or any grant have never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with Lorraine Locke, the grants writer and manager of the Hollywood
 Quarter. Councillor Worling considers that this non-pecuniary conflict of interest is not
 significant and does not require further action in the circumstances because details of this or
 any grant have never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a social relationship with the board of Pride Business Association, and has attended many of their events. Councillor Worling considers that this non-pecuniary conflict of interest is not significant and does not require further action in the circumstances because details of this or any grant have never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with Lorraine Locke, the grants writer and manager of the Rainbow
 Precinct. Councillor Worling considers that this non-pecuniary conflict of interest is not
 significant and does not require further action in the circumstances because details of this or
 any grant have never been discussed.
- a less than significant, non-pecuniary interest in Item 3 on the agenda, in that he has a
 community relationship with Renuka Fernado and Ben Stammer, the founders of Revolve.
 Councillor Worling considers that this non-pecuniary conflict of interest is not significant and
 does not require further action in the circumstances because details of this or any grant have
 never been discussed.

No other Councillors disclosed any pecuniary or non-pecuniary interests in any matters on the agenda for this meeting of the Innovation, Business and Economy Committee.

- (J) authority be delegated to the Chief Executive Officer to correct minor errors to the matters set out in this report, noting that the identity of the recipient will not change, and a CEO Update will be provided.
