

**Item 10.****Mobile Crane - Temporary Road Closure - Ebsworth Street, Zetland**

**Recommendations**

It is recommended that the Committee endorse the temporary road closure of Ebsworth Street, Zetland, between Bourke Street and Tweed Place, from 6.30am on Wednesday 5 December 2018 to 5.30pm Wednesday 12 December 2018, and from 6.30am on Wednesday 9 January 2019 to 5.30pm Thursday 10 January 2019, subject to the following conditions:

- (A) The Applicant must comply with the temporary road closure conditions as mentioned in Schedule B of this agenda.
- (B) The Applicant must comply with any other conditions imposed by City's Construction Regulation Unit.
- (C) The Applicant has indicated the Friday 11 January 2019 to Saturday 12 January 2019 as contingency dates.
- (D) The Applicant must contact the Redfern PAC to discuss deployment of user pay police for the road closure.
- (E) The Applicant is to obtain a Road Occupancy Licence from the Transport Management Centre prior to commencement of works.
- (F) The Applicant must provide a telephone number of the supervisor responsible for the proposed closure and include contact details in the notification letters to be distributed to affected stakeholders.

## Background

On 16 August 2018, the Committee endorsed the temporary road closures of Ebsworth Street, Zetland, between Bourke Street and Tweed Place, from 6.30am on Wednesday 24 October 2018 to 5.30pm on Wednesday 31 October 2018 and from 6.30am Wednesday 14 November 2018 to 5.30pm 15 November 2018. The Applicant indicated Thursday 1 November to 8 November 2018, and Wednesday 21 November 2018 to Thursday 22 November 2018 as contingency dates for these closures.

Due to the weather, these works were delayed. The Applicant is now seeking approval for the closure to occur from 6.30am on Wednesday 5 December 2018 to 5.30pm Wednesday 12 December 2018, and from 6.30am on Wednesday 9 January 2019 to 5.30pm Thursday 10 January 2019.

## Comments

The proposed temporary road closures are required to allow a mobile crane to be used to lift precast retaining panels onto the Crown Green Square development site, 301-303 Botany Road, Zetland.

The Applicant has provided a site-specific Traffic Control Plan that includes details of barricades, signs, flagmen and other traffic devices to implement the proposed road closures.

The temporary road closures will not affect any other properties, as local access will be provided at all times and alternative access routes are available nearby.

A Traffic Management Plan (TMP) for the temporary road closure was approved by Roads and Maritime Services (RMS).

## Consultation

The Applicant will be required to notify affected stakeholders as stipulated in Schedule B.

## Financial

All costs associated with the proposed closures will be borne by the applicant.
