1. This plan may be cited as "Newcastle Local Environmental Plan No. 71".

#### Aims, objectives, etc.

2. This plan aims to rezone the land to which this plan applies from Residential "A" to Special Uses "A" under the Northumberland Local Environmental Plan to provide for the development of community facilities.

No. 90, 6th June, 1986—4

#### Land to which plan applies

#### Aims, objectives, etc.

#### Land to which plan applies

3. - (iv) on 27th November, 1986, revoked the delegation made by the Director on 9th October, 1986, to C. J. Oliver, an employee of the Wyong Shire Council, of the functions referred to in (ii) and again delegated (subject to different limitations) those functions to him.
