### Planning proposal to amend Sydney Local Environmental Plan 2012

I am writing in response to your Council's letter dated 4 November 2016 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 (the Act) in respect of the planning proposal to list displays of goods on footpaths as exempt development.

As delegate of the Greater Sydney Commission, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Greater Sydney Commission may take action under section 54(2)(d) of the Act if the time frames outlined in this determination are not met.

### **Gateway Determination**

**Planning proposal (Department Ref: PP\_2016\_SYDNE\_008\_00)**: to list displays of goods of footpaths as exempt development.

I, the Director, Sydney Region East at the Department of Planning and Environment as delegate of the Greater Sydney Commission, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Sydney Local Environmental Plan (LEP) 2012 should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
  - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Department of Planning and Infrastructure 2013)* and must be made publicly available for a minimum of **14 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Environment 2016).
- 2. No consultation is required with public authorities under section 56(2)(d) of the Act.
- 3. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 4. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.



I refer to your letter seeking an extension of time to complete planning proposal PP\_2016\_SYDNE\_008\_00 (as altered) to introduce displays of goods on the footway as exempt development.

I have determined as the delegate of the Minister for Planning and Public Spaces, in accordance with section 3.34(7) of the *Environmental Planning and Assessment Act 1979*, to alter the Gateway determination dated 18 March 2019 for PP\_2016\_SYDNE\_008\_00. The Alteration of Gateway determination is enclosed.

The Department notes that the Gateway has been extended on four occasions for a total of 33 months, and considers this to be a generous amount of time. The Department therefore recommends that the date be extended to 25 August 2020 to allow sufficient time for reporting, drafting with Parliamentary Counsel and finalisation of the LEP.

However, if the LEP amendment is not made by 25 August 2020, the Department recommends Council consider withdrawing the planning proposal.

Given the initial Gateway Determination was issued in November 2016, the Department recommends that Council consider updating the planning proposal to:

- demonstrate the proposal is consistent with the State Environmental Planning Policy (Exempt and Complying Development Codes) 2008, Section 9.1 Ministerial Directions and the Eastern City District Plan; and
- reflect RMS comments in relation to prohibitions, clearances and public liabilities.
