Executive Summary:

Council received correspondence from the Commissioner of Fire and Rescue NSW (FRNSW) in relation to the subject premises with respect to matters of fire safety.

The premises consist of a 22-storey mixed use commercial and retail building exceeding 25 metres in height.

FRNSW raised issues relating to the buildings existing fire hydrant system, which was originally installed to meet the applicable standard at the time of installation. FRNSW have advised that they no longer use portable relay pumps for internal booster relay connections for the hydrant system. The subject buildings fire hydrant system currently relies upon the use of portable relay pumps.

Council investigations reveal that the premises lack adequate facilities to assist FRNSW in firefighting and rescue operations, and that a fire safety order to be issued under Schedule 5 of the Environmental Planning and Assessment Act, 1979 is required to ensure and promote adequate facilities for fire safety.

Inspection of the external features of the building did not identify the existence of potential combustible composite cladding on the façade of the building.

Fire and Rescue NSW received correspondence in relation to the adequacy of the provision for fire safety in connection with the premises.

The correspondence states in part that "FRNSW are required to transport portable relay pumps to the Ordinance 70 building booster connection on Level 17"

Issues

The report from FRNSW details the following issues with regards to the building located at 173-179 Pitt Street, Sydney:

- 1. Essential Fire Safety Measures
 - 1A. Fire Hydrant System
 - A. An internal booster connection is installed on Level 18 for the connection of a portable pumpset to conduct firefighting operations.
 - Ordinance 70 and Australian Standard (AS) 2419.1-1994 permitted the use of an internal booster connection for portable relay pumps to be installed in buildings above 75 metres or as required by the regulatory authority, to provide a pressurised water source for firefighting operations on the upper levels of the building. In this regard, the use of portable relay pumps, no longer suits the operational needs of FRNSW.
 - B. A fire hydrant pumpset located at the roof top plant room was out of service at the time of inspection. Maintenance contractors advised that parts were yet to be delivered.

FRNSW Recommendations

FRNSW recommends that Council:

- a. Inspect and address any other deficiencies identified on 'the premises' and require item no. 1A of this report be addressed appropriately.
- b. Upgrade the fire hydrant system, to operate without the need for a portable relay pump, to meet the requirements of the current AS2419.1 for an equivalent new building, as these older fire hydrant systems no longer meet the operational requirements of FRNSW.

The issue of a fire safety order will ensure that suitable fire safety systems are in position throughout the building to provide improved and adequate provisions for fire safety

Fire & Rescue NSW (FRNSW) received correspondence in relation to the adequacy of the provision for fire safety in connection with 'the premises'.

The correspondence stated in part that:

 FRNSW are required to transport portable pumps to the Ordinance 70 building. Booster connection Level 18

Pursuant to the provisions of Section 9.32 (1) of the *Environmental Planning and Assessment Act 1979* (EP&A Act), an inspection of 'the premises' on 8 March 2021 was conducted by Authorised Fire Officers from the Fire Safety Compliance Unit of FRNSW.

The inspection was limited to the following:

- A visual inspection of the essential Fire Safety Measures as identified in this report only.
- A conceptual overview of the building, where an inspection had been conducted without copies of the development consent or copies of the approved floor plans.

COMMENTS

The following items were identified as concerns during the inspection:

- Essential Fire Safety Measures
 - 1A. Fire Hydrant System
 - A. An internal booster connection is installed on Level 18 for the connection of a portable pumpset to conduct firefighting operations.
 - Ordinance 70 and Australian Standard (AS) 2419.1-1994 permitted the use of an internal booster connection for portable relay pumps to be installed in buildings above 75 metres or as required by the regulatory authority, to provide a pressurised water source for firefighting operations on the upper levels of the building. In this regard, the use of portable relay pumps, no longer suits the operational needs of FRNSW.

FRNSW is therefore of the opinion that there are inadequate provisions for fire safety within the building.

RECOMMENDATIONS

- b. Upgrade the fire hydrant system, to operate without the need for a portable relay pump, to meet the requirements of the current AS2419.1 for an equivalent new building, as these older fire hydrant systems no longer meet the operational requirements of FRNSW.

This matter is referred to Council as the appropriate regulatory authority. FRNSW therefore awaits Council's advice regarding its determination in accordance with Schedule 5, Part 8, Section 17 (4) of the EP&A Act.
