Summary of submissions and responses: draft Sustainable Sydney 2030-2050 Continuing the Vision & draft Community Strategic Plan Delivering Sustainable Sydney 2030-2050

42 emailed submissions were received in total following the exhibition of the draft Sustainable Sydney 2030-2050 Continuing the Vision and the draft Community Strategic Plan Delivering Sustainable Sydney 2030-2050. Also included are 10 responses from organisations provided to the questions on Sydney Your Say. A summary of the issues raised in the submissions and responses and the recommendation following their assessment by staff are included in the table below.
