Under City policy, if companion animals are desexed, pensioners are able to register one companion animal for free, and additional animals may be registered for \$10.00 each. City Rangers have confirmed that this concession is also available for companion animals not desexed on veterinary recommendation. A comment/note has been added to outline that the City's pricing policy of reduced fees for eligible pensioners also applies in the case of the veterinary recommendation for exemption from de-sexing. The fee descriptions have also been changed to delete 'Desexed Animal' - they now read 'First Animal' and 'Additional Animal' respectively.
