

## Proposal

- alterations and additions to the Cathedral of the Annunciation of Our Lady
- alterations and additions to former St Paul's rectory for use as a chapel,
   Dean's residence, offices and college domiciles
- demolition of existing function hall and parish hall
- construction of two new buildings with shared basement for use as shared function spaces, museum, library, office, and theological college, college domiciles and shared facilities
- Integrated Development under the Heritage Act 1977































Ground floor plan



## Height





### Height

- Clause 4.6 request is supported
- majority of building under height limit
- strict compliance would result in stepped built form
- new building complies with 3 storey DCP height control
- domes are architectural roof features which are permissible above the height control



#### **Trees**

- 9 trees proposed for removal
- Heritage NSW approved removal of all trees
- Councils tree management unit objected to removal of 5 of the trees
- Planning staff sought to retain 2 significant trees on Cleveland Street frontage

trees City staff sought to retain



#### **Trees**

- applicant amended scheme to reconfigure car park and driveways to retain the trees
- TfNSW did not grant concurrence to amended proposal
- options to save the trees and provide vehicle access acceptable to TfNSW were workshopped
- trees unable to be retained
- applicant has agreed to plant a replacement mature specimen
- 15% canopy cover across the site will be achieved



### Heritage

- site is state and local heritage item
- proposal involves demolition of Parish Hall (c. 1913)
- SDCP 2012 would seek to retain parish hall building older than 50 years and of heritage significance
- the building has been substantially altered internally and externally, and its demolition is supportable in the context of creating a more suitable space for the Cathedral complex
- Heritage NSW have granted general terms of approval for the development



#### Hours of operation

- DCP controls allow late uses until 12 midnight
- proposed base hours 8.00am to 8.00pm
- proposal to operate until 3am the following day on Christmas Eve and Easter Saturday is in line with Greek Orthodox tradition
- the site has been the seat of Greek orthodoxy in Australia since 1970
- midnight services at Easter and Christmas already take place legally on the site
- hours recommended for approval on a permanent basis



### Traffic Management

- submissions raised existing issues with traffic management at special events
- conditions of consent recommended to help mitigate traffic impacts which require:
  - Guest Drop off and Pick up Management Plan
  - Special Events Traffic and Transport Management Plan
  - Transport Access Guide



#### Church bells

- submissions raised existing issues regarding noise from the church bells and seeking noise to be regulated
- the applicant has agreed to restrict ringing of church bells to within operating hours within the Plan of Management
- as the proposal does not seek to change the use of the Cathedral, which has been ongoing for 175 years, it would not be reasonable to impose further conditions restricting the use of the church bells



#### Recommendation

- Deferred commencement approval subject to conditions
- Deferred commencement conditions were imposed by Sydney Trains and Heritage NSW
- the conditions require additional investigations and documentation to be prepared and submitted prior to the consent becoming operational
