

- SURROUNDING PROPERTY ACCESS TO BE MAINTAINED AT ALL TIMES.
- GEDDES AVENUE CLOSED BETWEEN BOTANY ROAD AND PAUL STREET TO ALL NON-SITE VEHICLES. PEDESTRIAN BARRIERS INSTALLED AROUND THIS AREA TO CREATE AN EXCLUSION ZONE FOR PEDESTRIANS.

- TRAFFIC APPROACHING THE CLOSURE AREA TO BE DIRECTED ALONG DETOUR ROUTES. SEE SBMG02241-30 FOR DETOUR PLAN.
- PEDESTRIANS AND CYCLISTS DIRECTED TO USE THE FOOTPATH ON THE NORTHERN SIDE OF GEDDES AVENUE WHICH IS TO BE TEMPORARILY USED AS A SHARED PATH DURING THE ROAD CLOSURE TO TRAVEL PAST THE SITE. EXISTING CROSSING POINTS TO BE USED TO ACCESS THE DETOUR ROUTE.
- TRAFFIC CONTROLLERS TO ASSIST VEHICLES WHERE REQUIRED TO TRAVEL BETWEEN PAUL STREET AND THE NEIGHBOURING SITE PARKING AREA BY TRAVELING WITHIN THE CLOSURE AREA.
