

Item 18.**Works Zone - Brisbane Street, Surry Hills**

Recommendations

It is recommended that the Committee endorse the reallocation of the kerb space on the western side of Brisbane Street, Surry Hills, between the points 93 metres and 111 metres south of Oxford Street as "Works Zone 7.30am – 5.30pm Mon-Fri, 7.30am-3.30pm Sat" and "No Parking All Other Times", subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule C of this agenda.
- (B) The Applicant is not permitted to operate any part of a crane over a public road or hoist/swing goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Construction and Building Certification Services Unit as required under Section 68 of the Local Government Act 1993 and Section 138 of the Roads Act 1993.
- (C) The Applicant must notify adjacent properties of the Works Zone at least 14 days prior to installation and must provide a telephone number of the supervisor responsible for the proposed Works Zone and include contact details in the notification letter to be distributed to affected stakeholders.
- (D) The Applicant must provide TfNSW-Accredited Traffic Controllers to safely manage the operation of the Works Zone and maintain local vehicular access in Brisbane Street at all times. If approaching traffic or vehicles exiting driveways opposite cannot pass a vehicle in the Works Zone, the TfNSW-Accredited Traffic Controllers must instruct the construction vehicle to depart the Works Zone immediately.

Background

Trescon Pty Ltd has requested an 18 metre long Works Zone in Brisbane Street, Surry Hills.

The Works Zone is to facilitate construction works at 9-13 Brisbane Street, Surry Hills.

Comments

The kerb space on the western side of Brisbane Street, Surry Hills between Oxford Street and Goulburn Street is currently signposted as "No Parking". The opposite side of the street is also signposted as "No Parking" because of some driveways.

The Works Zone is intended to operate from 7.30am – 5.30pm Monday to Friday 7.30am-3.30pm on Saturday in accordance with the Development Consent Conditions. Outside of these hours, the kerb space where the works zone is proposed, will revert to "No Parking All Other Times"

Brisbane Street is a 5 metre one way street and is wide enough to allow the Works Zone to be installed without affecting traffic flow.

TfNSW Accredited Traffic Controllers will manage the operation of the Works Zone and maintain vehicular access to nearby driveways at all times.

Consultation

The applicant must notify adjacent properties at least 14 days prior to the implementation of the Works Zone.

Financial

All costs associated with the Works Zone will be borne by the Applicant.
