Works Zone - Macquarie Street, Sydney

#### Recommendations

It is recommended that the Committee endorse the following reallocation of the kerb space as follows:

- (A) On the western side of Macquarie Street, Sydney between the points 58.2 metres and 63.7 metres north of Bent Street as "Works Zone 7am-7pm Mon-Fri 7am-5pm Sat" and "4P Ticket 7-10pm Mon-Fri 5-10pm Sat 8am-10pm Sun & Public Holidays";
- (B) On the western side of Macquarie Street, Sydney, between the points 63.7 metres and 75.2 metres north of Bent Street as "Works Zone 7am-7pm Mon-Fri 7am-5pm Sat" and "No Parking All Other Times"; and
- (C) On the western side of Macquarie Street, Sydney, between the points 101.2 metres and 107.2 metres north of Bent Street as "No Parking 7am-7pm Mon-Fri Consular Vehicles Excepted" and "4P Ticket 7-10pm Mon-Fri 8am-10pm Sat, Sun & Public Holidays".

Subject to the following conditions:

- (D) The Applicant must comply with the Works Zone conditions as stipulated in Schedule C of this agenda.
- (E) The Applicant must obtain separate approval from the City's Tree Management Team prior to implementation of the Works Zone.
- (F) The Applicant is not permitted to operate any part of a crane over a public road or hoist/swing goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Construction and Building Certification Services Unit as required under Section 68 of the Local Government Act 1993 and Section 138 of the Roads Act 1993.
- (G) The Applicant must notify adjacent properties of the Works Zone at least 14 days prior to installation and must provide a telephone number of the supervisor responsible for the proposed Works Zone and include contact details in the notification letter to be distributed to affected stakeholders.

## **Background**

Buildcorp Group Pty Ltd has requested a 17 metre long Works Zone in Macquarie Street, Sydney to facilitate the construction works at 151 Macquarie Street.

### **Comments**

The kerb space on the western side of Macquarie Street, north of Bent Street, where the Works Zone is proposed, is currently signposted as "No Parking" and "4P Ticket 7-10pm Mon-Fri 8am-10am Sat, Sun & Public Holidays" and "No Parking 7am-7pm Mon-Fri Consular Vehicles Excepted".

The one "No Parking 7am-7pm Mon-Fri Consular Vehicles Excepted" parking space will be reallocated further north on Macquarie Street.

The Works Zone is intended to operate from 7am to 7pm, Monday to Friday and 7am to 5pm on Saturday in accordance with City's standard construction hours for projects in the city centre.

The Works Zone will revert to Ticket parking and "No Parking All Other Times" after the Works Zone hours.

### Consultation

The applicant must notify adjacent properties at least 14 days prior to the implementation of the Works Zone.

All costs associated with the Works Zone will be borne by the Applicant.
