The Draft Central Sydney Planning Strategy, Appendix D provided a detailed analysis of the existing wind, sun and sky view conditions in the precinct. The report found the following;

- Street intersections are an important source of light into the street network and the sky view is significantly greater at intersections.
- The north side of east-west streets are permanently in shade, but the east-west streets are shorter and wider, with wider views in the distance;
- East-west streets are frequently intersected and the intersections create injections of daylight; and
- North-south streets benefit from northerly sun throughout the middle of the day, but are dark in the mornings and afternoons.

### EXISTING MICROCLIMATIC CONDITIONS




### STREET TREE HEALTH


