

**Item 12.****Works Zone - Goulburn and Pitt Streets, Sydney**

**Recommendations**

It is recommended that the Committee endorse the reallocation of the kerb space as follows:

- (A) On the northern side of Goulburn Street, Sydney between the points 34 metres and 49 metres west of Pitt Street as "Works Zone 8pm-5am Mon-Wed, 9.30pm-5am Thu" and "No Stopping All Other Times"; and
- (B) On the western side of Pitt Street, Sydney between the points 63 metres and 78 metres north of Goulburn Street, as "Works Zone 7am-7pm Mon-Fri, 7am-5pm Sat" and "P5 Minute All Other Times".

Subject to the following conditions:

- (A) The Applicant must comply with the Works Zone conditions as stipulated in Schedule C of this agenda.
- (B) The Applicant must inform TMC of the proposed Works Zone on Goulburn Street.
- (C) The Applicant is not permitted to operate any part of a crane over a public road or hoist/swing goods from a Works Zone across or over any part of a public road by means of a lift, hoist or crane unless a separate approval has been obtained from the City's Construction and Building Certification Services Unit as required under Section 68 of the Local Government Act 1993 and Section 138 of the Roads Act 1993.
- (D) The Applicant must notify adjacent properties of the Works Zone at least 14 days prior to installation and must provide a telephone number of the supervisor responsible for the proposed Works Zone and include contact details in the notification letter to be distributed to affected stakeholders.

### **Background**

MPA has requested a 15 metre long Works Zone in Goulburn Street and 15 metre long Works Zone in Pitt Street.

The two Works Zone is to facilitate construction works at 52 Goulburn Street, Sydney.

### **Comments**

The kerb space on the northern side of Goulburn Street, Sydney between George and Pitt Streets is currently signposted as "No Stopping". The kerb space on the western side of Pitt Street, between Goulburn and Liverpool Streets is currently signposted as "P5 Minute" parking.

Transport for NSW has been consulted for the Works Zone on Goulburn Street and raised no objections for the hours of 8pm to 5am Monday to Wednesday and 9.30pm to 5am Thursday.

The Works Zone on Pitt Street is intended to operate from 7am to 7pm, Monday to Friday and 7am to 5pm, Saturday in accordance with the Development Consent Conditions.

Outside of the Works Zone hours, the kerb side restrictions will revert to "No Stopping All Other Times" on Goulburn Street and "P5 Minute All Other Times" on Pitt Street.

### **Consultation**

The applicant must notify adjacent properties at least 14 days prior to the implementation of the Works Zone.

### **Financial**

All costs associated with the Works Zone will be borne by the Applicant.
