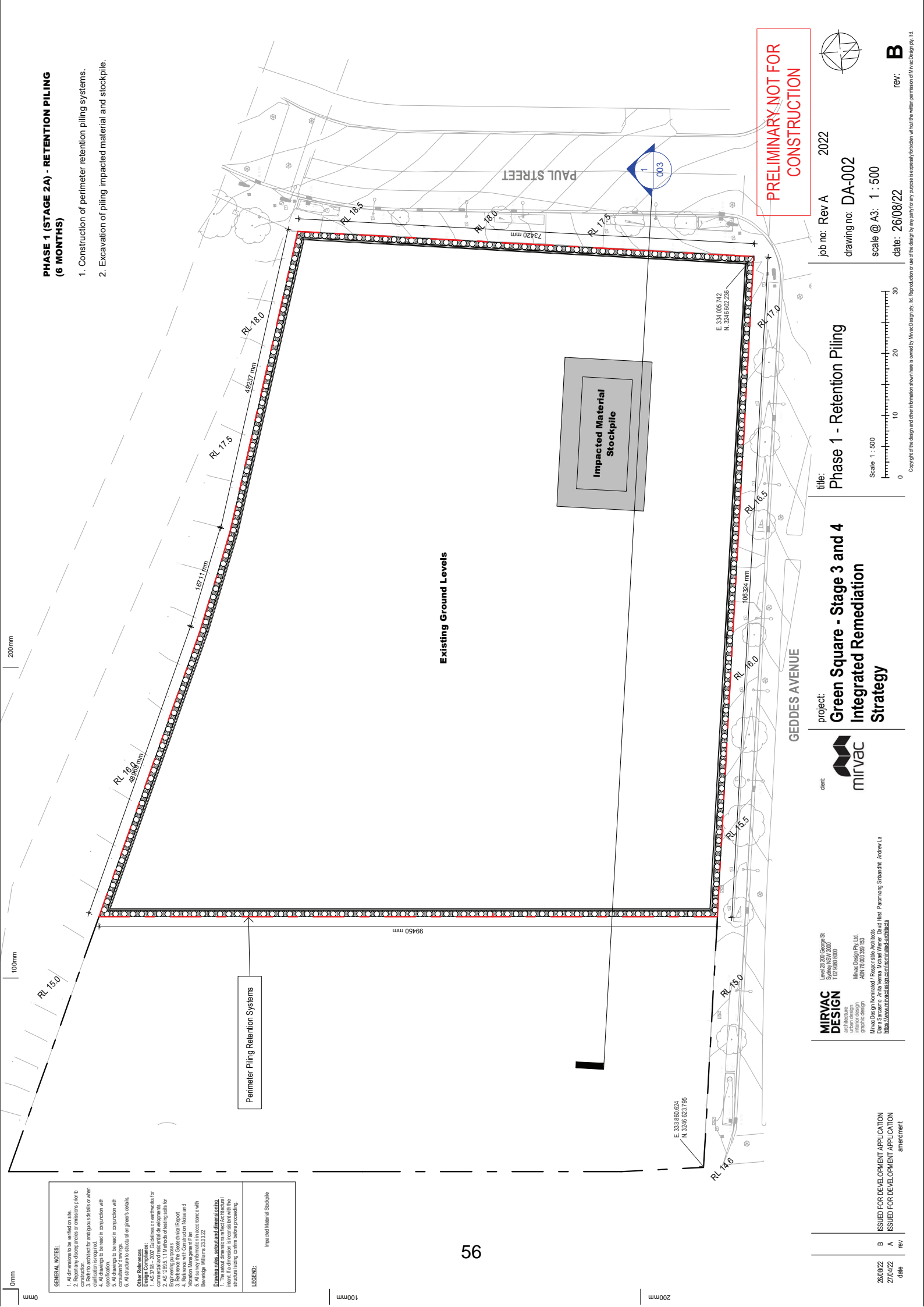

Existing Ground Levels

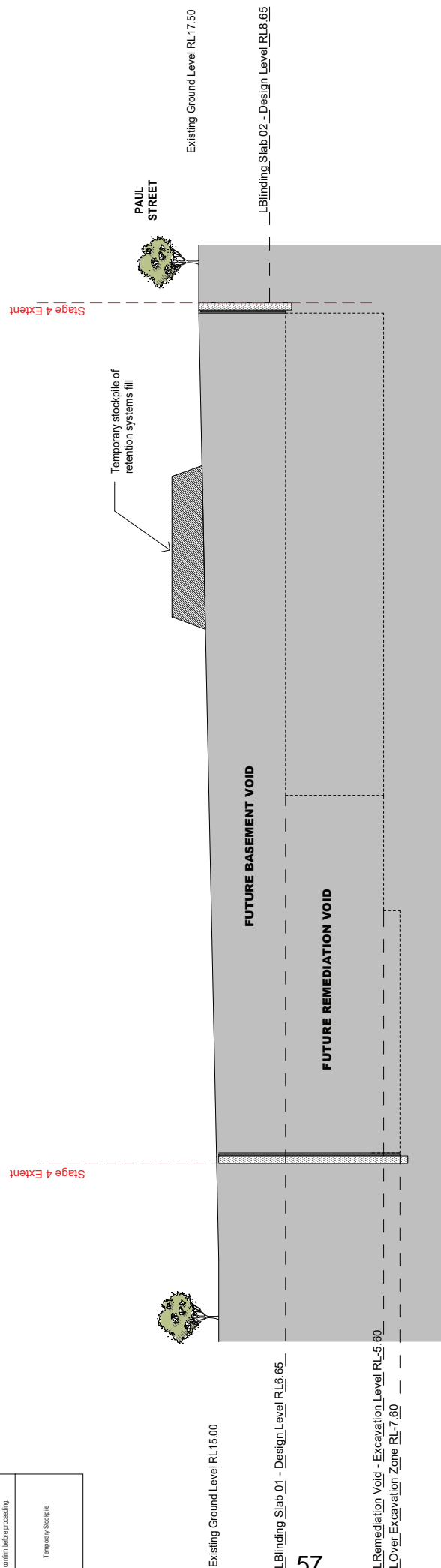

2. Backfilling and spreading of impacted material within void.

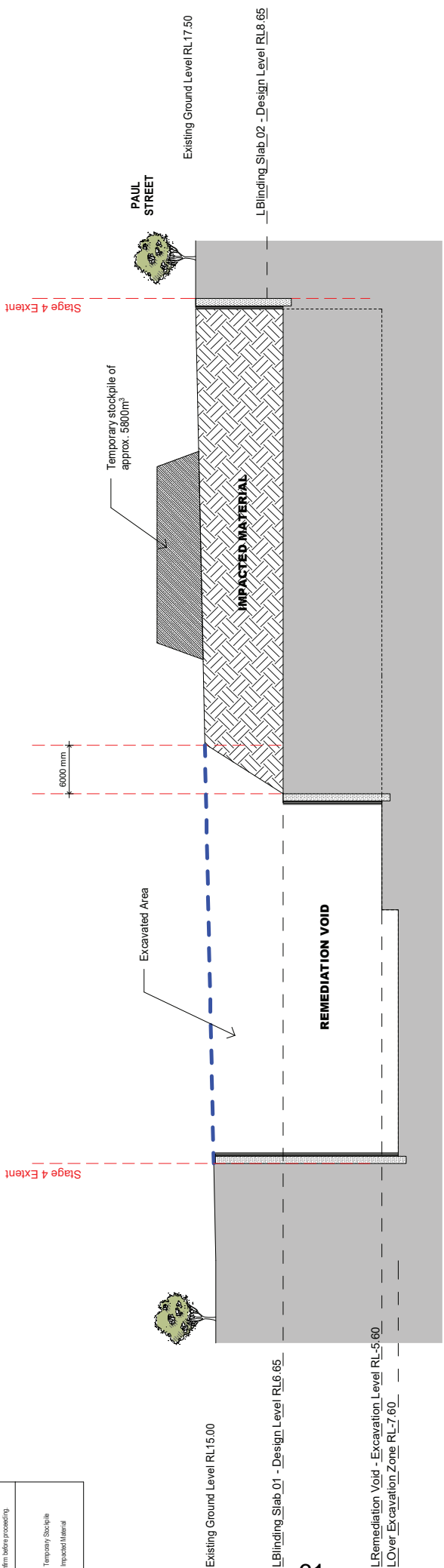

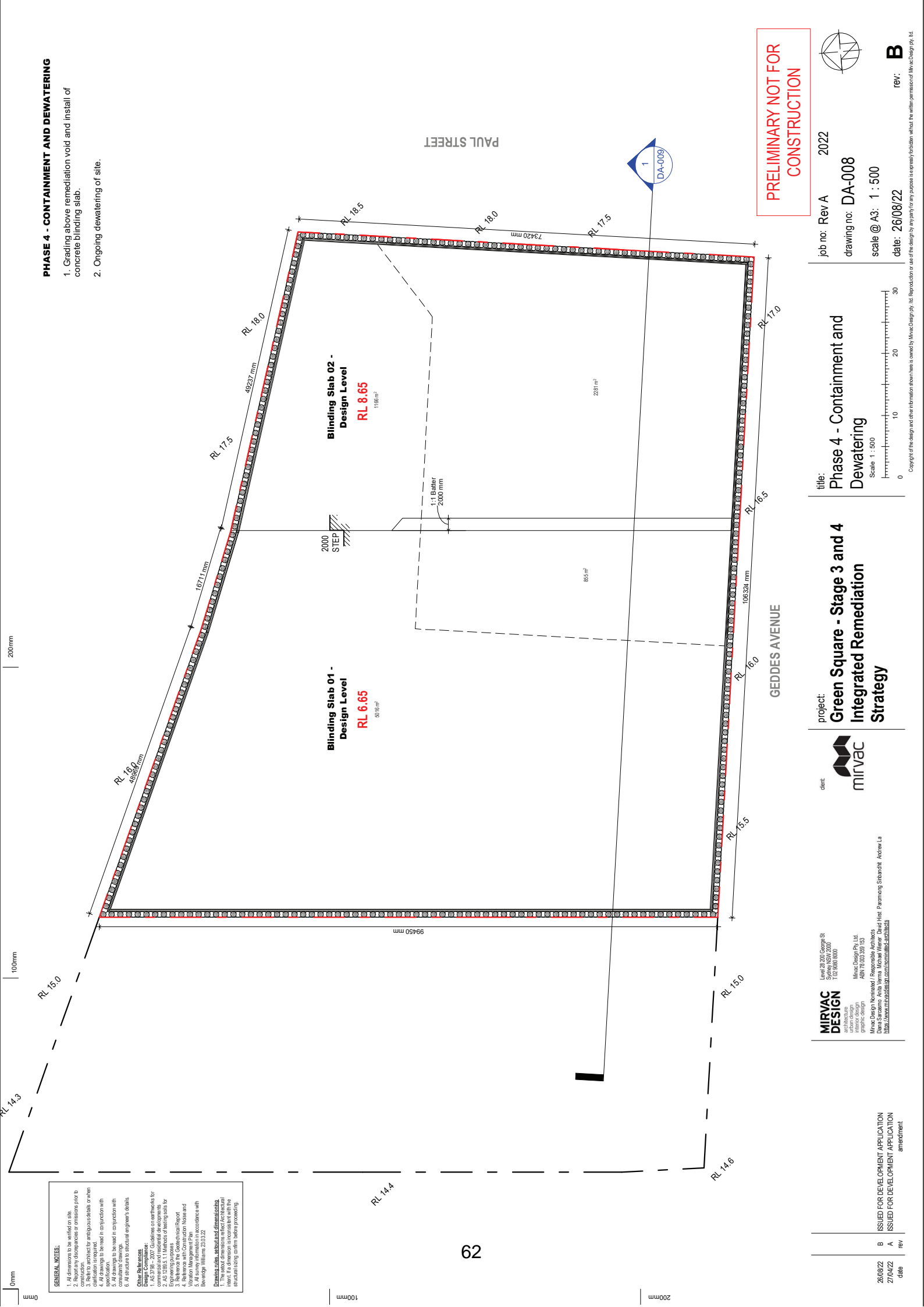
