# Background

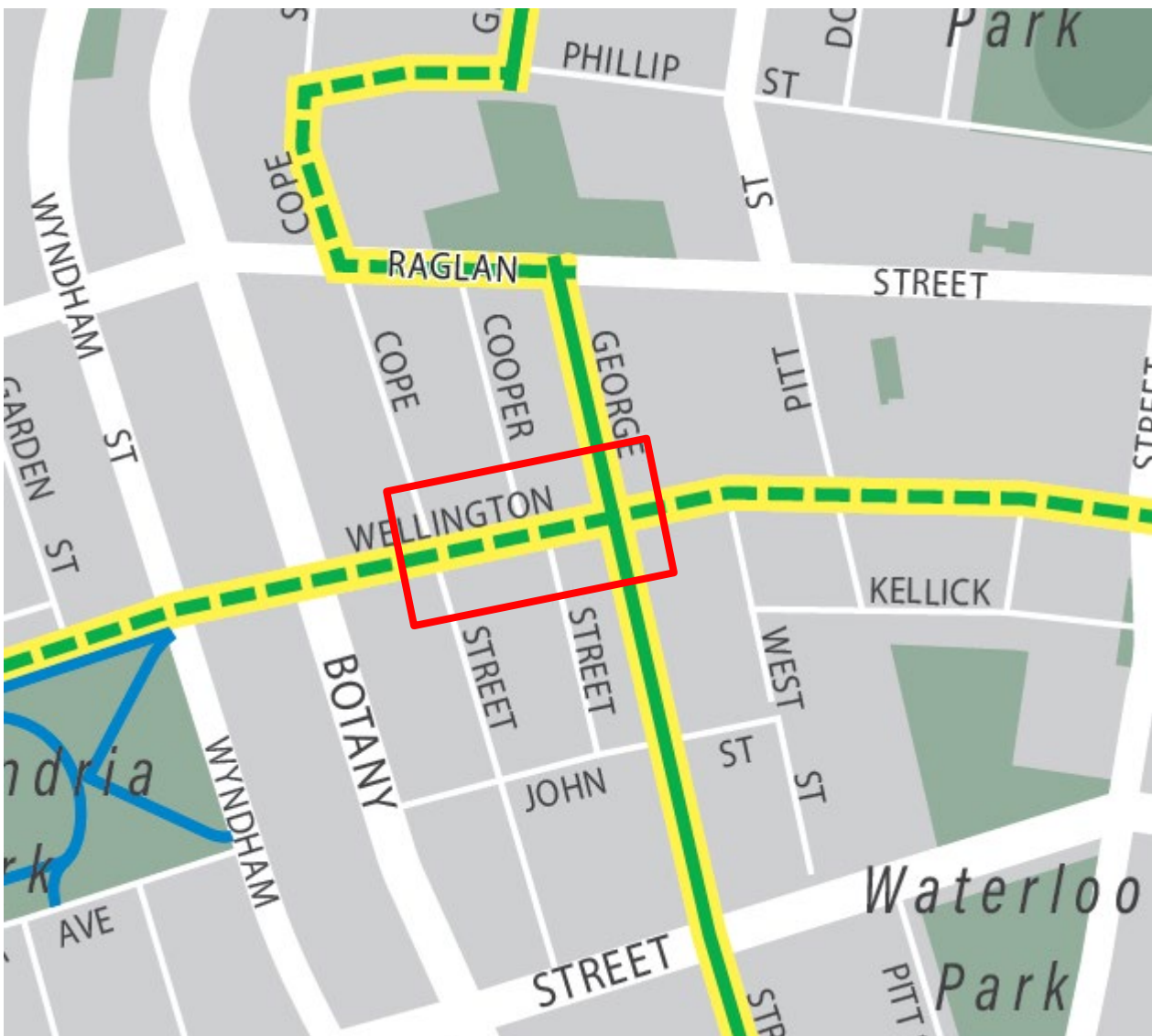
The City proposes a conventional running, one-way cycleway on each side of the street on Wellington Street, between Cope and George streets.

The project includes:

- 2 one-way cycleways on each side of the street between Cope and George streets
- reducing the existing kerb at George Street to provide a safe transition for people riding
- changing the existing traffic priority for vehicles travelling north-south to east-west.

No trees will be affected by the proposal. However, the project requires removing 10 parking spaces.

New pedestrian crossings at Cope Street will be provided by Transport for NSW as part of the Waterloo Metro station project.



# Engagement Summary

---

## We asked the community for feedback on the concept design

Consultation on the plan ran between 1 May and 29 May 2023 and provided an opportunity for stakeholders and the community to review and comment on the proposed design.

Consultation activities included an online survey and interactive map, two information sessions at the road closure at the intersection of George and McEvoy streets and a letter to residents and businesses. Staff attended the Waterloo Wellbeing and Safety Action Group.

This report outlines the community engagement activities that took place to support the consultation and summarises the key findings from the consultation.

## Purpose of the engagement

The purpose of the engagement was to:

- Get feedback on walking and cycling improvements
  - Find out about access to properties and how people currently use the area
  - Determine if anything had been missed by calling on local knowledge
- 

## Engagement activities

### Sydney Your Say webpage

A Sydney Your Say webpage was created. The page included an interactive map of the proposed design. People could insert their feedback directly onto the map and up-vote and down-vote ideas.

### Interactive map

The Sydney Your Say page included a link to an interactive map of the proposed design. The community and stakeholders could insert their feedback directly onto the map and up-vote and down-vote ideas.

### Consultation letter

A letter was posted to residents, inviting them to give feedback on the proposal. **1050 letters** were distributed.

### Information sessions

Two information sessions were held at the road closure at the intersection of George and McEvoy streets where the project team were available to discuss the project on-site.

- Tuesday 16 May 4pm to 5:30pm
- Thursday 18 May 8am to 9:30am

Approximately 40 people attended the sessions

## Outcomes from the engagement

Feedback was received through the interactive map, an online survey and via email.

- The Sydney Your Say page was visited 359 times during the consultation period.
- 27 people left a total of 55 comments on our interactive map
- 4 email submissions were received
- 40 people (approx.) attended the information sessions at the intersection of George and McEvoy Streets.

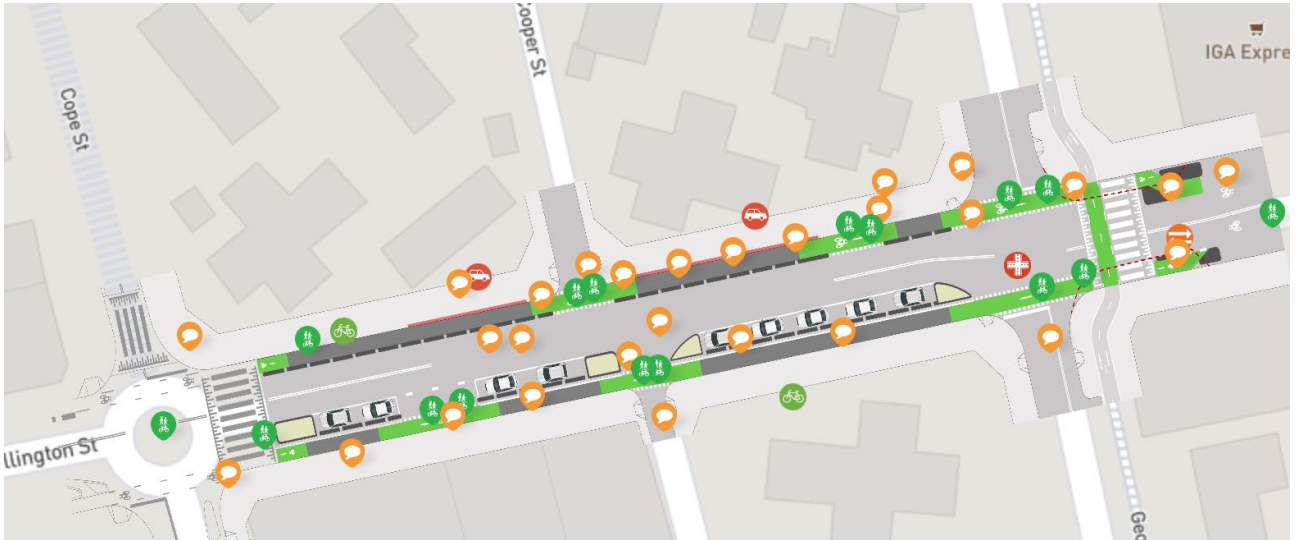
