

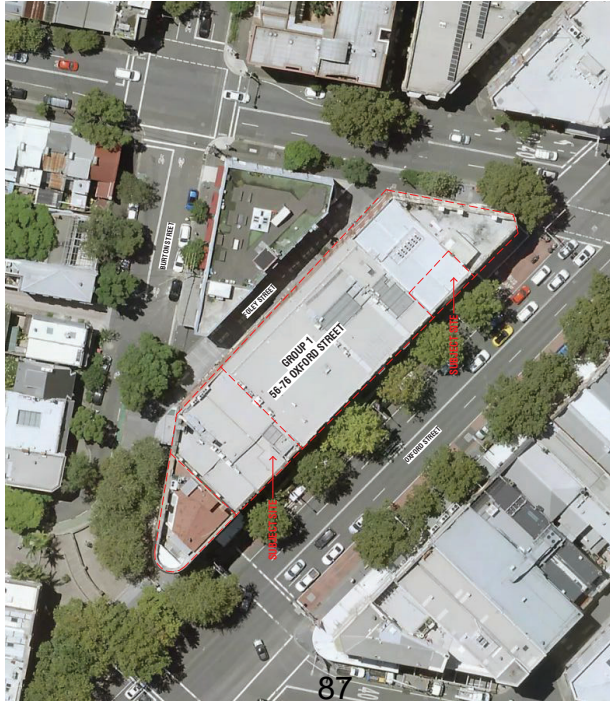

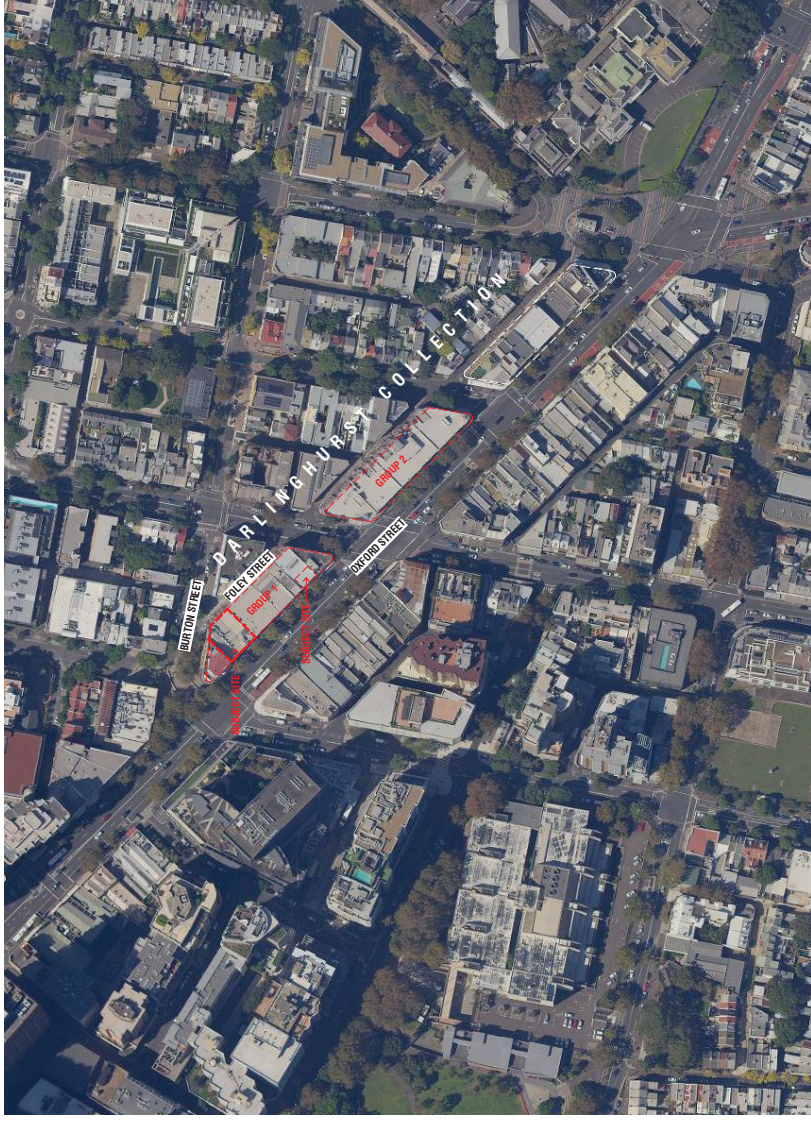

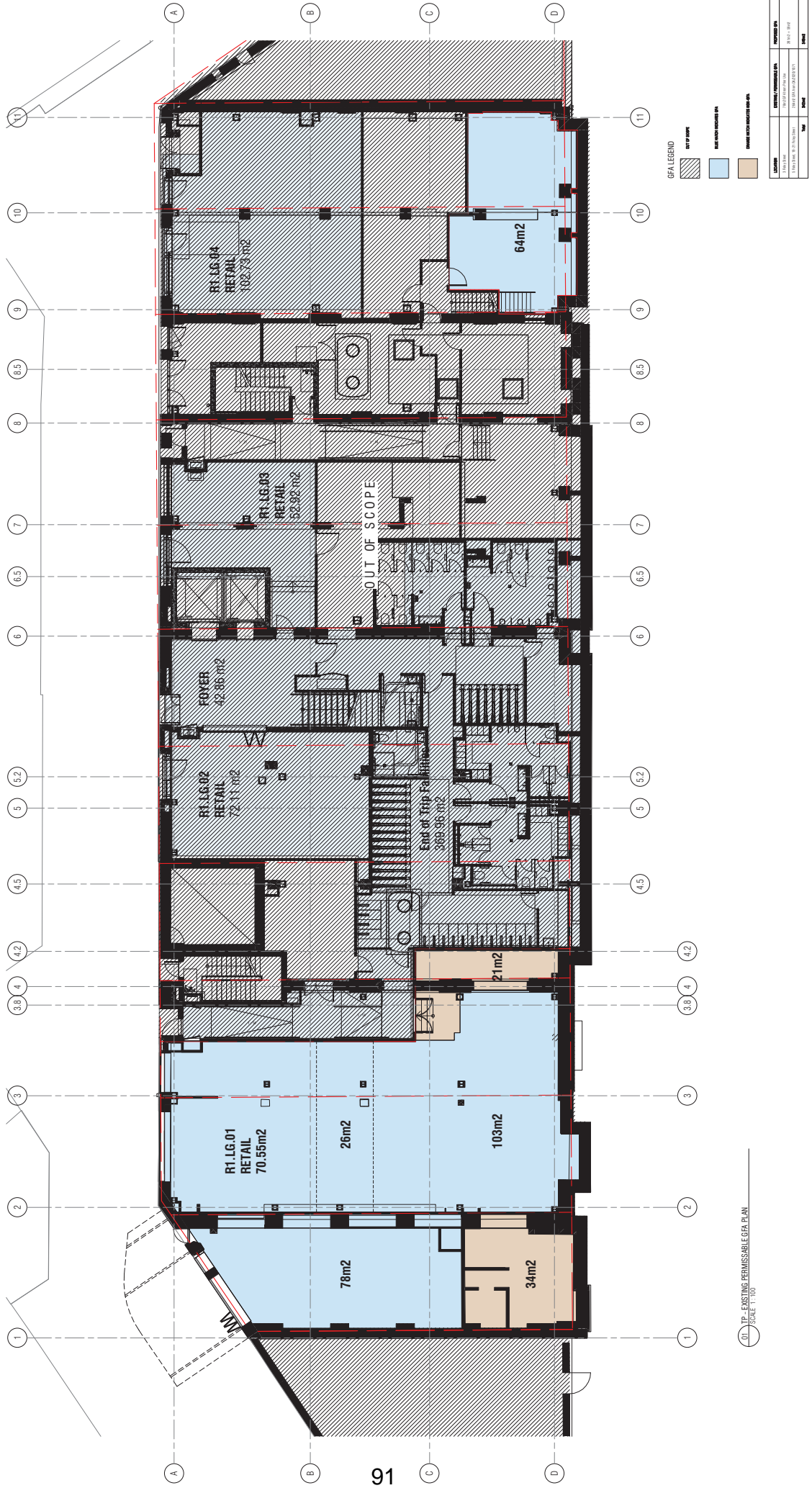
LOCATION PLAN

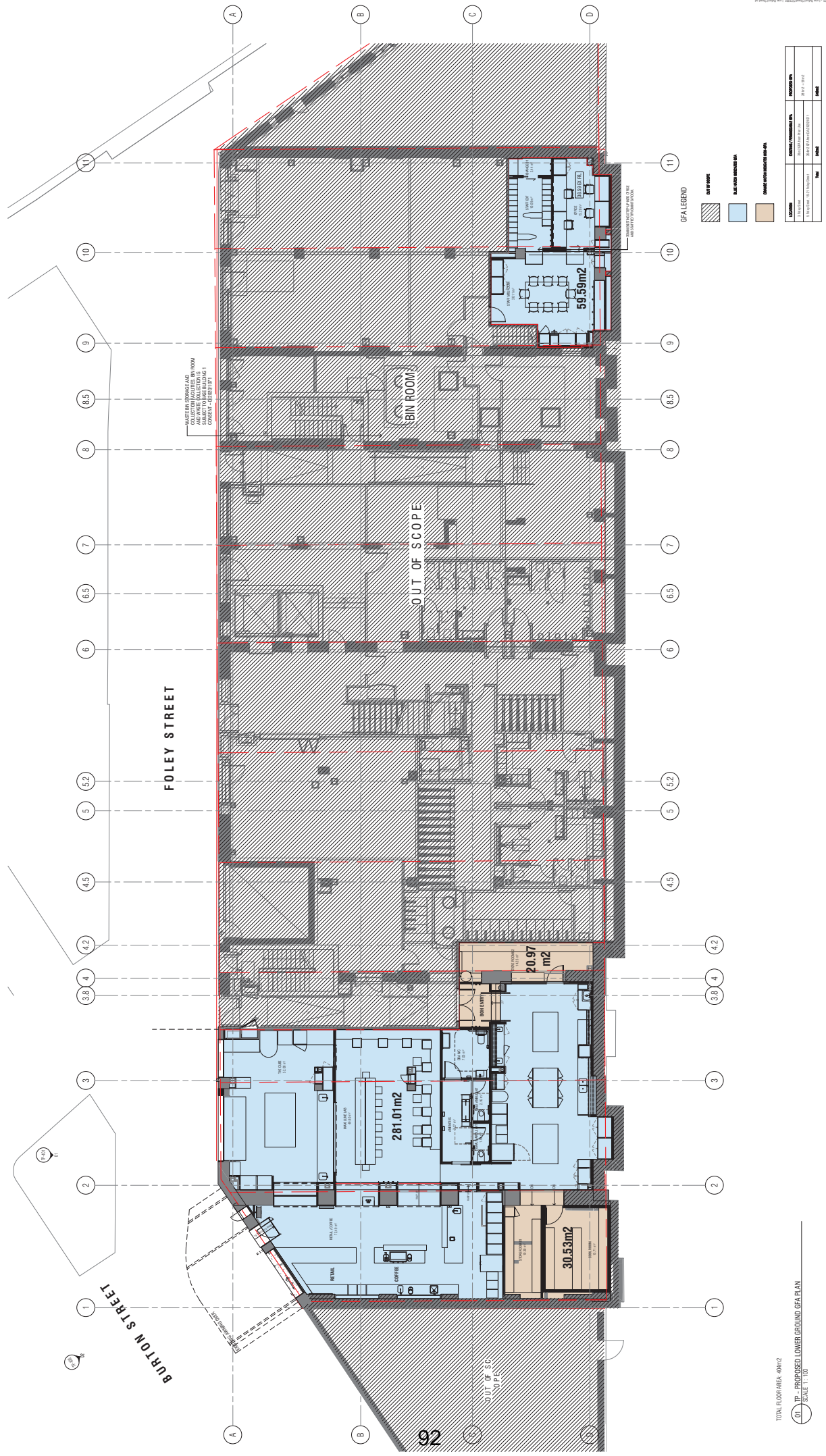

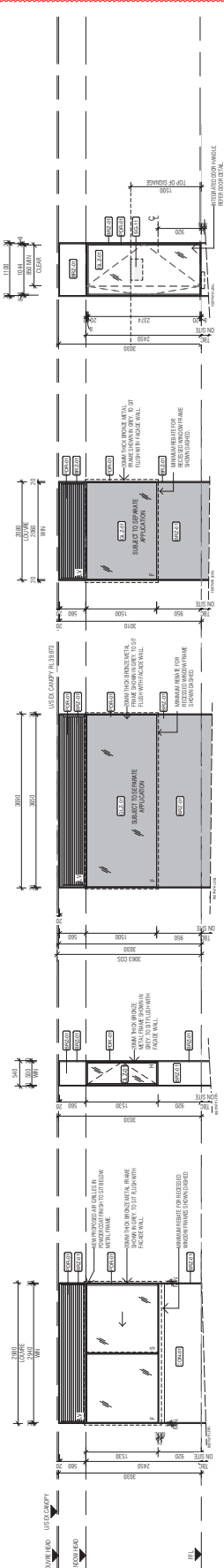
