Proposal

- installation of one 'single' Automated Public Toilet (APT) comprising 1 accessible toilet and 3 green wall panels

Recommendation

- approval subject to conditions

Background

- community consultation on Woolloomooloo Playground upgrades during mid 2020
- proposed APT was not part of playground upgrades
- letters of support and advocacy for an APT in this location were received in 2021 after completion of playground upgrades consultation
- community initiative and support for proposal from local community groups, charities and Plunkett Street Public School
- APT intended to serve well-utilised community playground

Notification

- notification period 23 May 2022 to 21 June 2022
- re-notification period 14 October 2022 to 12 November 2022 due to a correction of site address
- 806 owners and occupiers notified
- 21 submissions received, including a petition containing 122 signatures objecting to the proposal

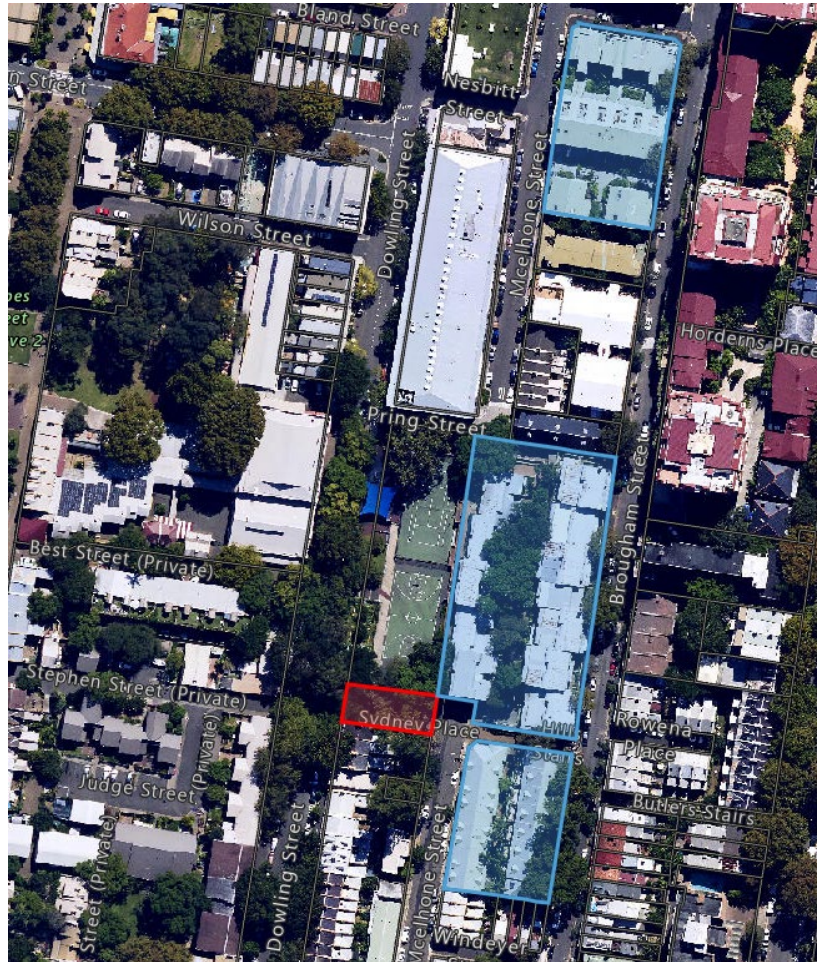
Submissions (support / comments)



- support for the APT to serve well-utilised community playground
- requested by parts of the community for some time
- facility will support playground users and community events
- lack of existing facility leads to public urination
- request for the APT to provide a baby change facility and facilitate all abilities access

Submissions (objections)

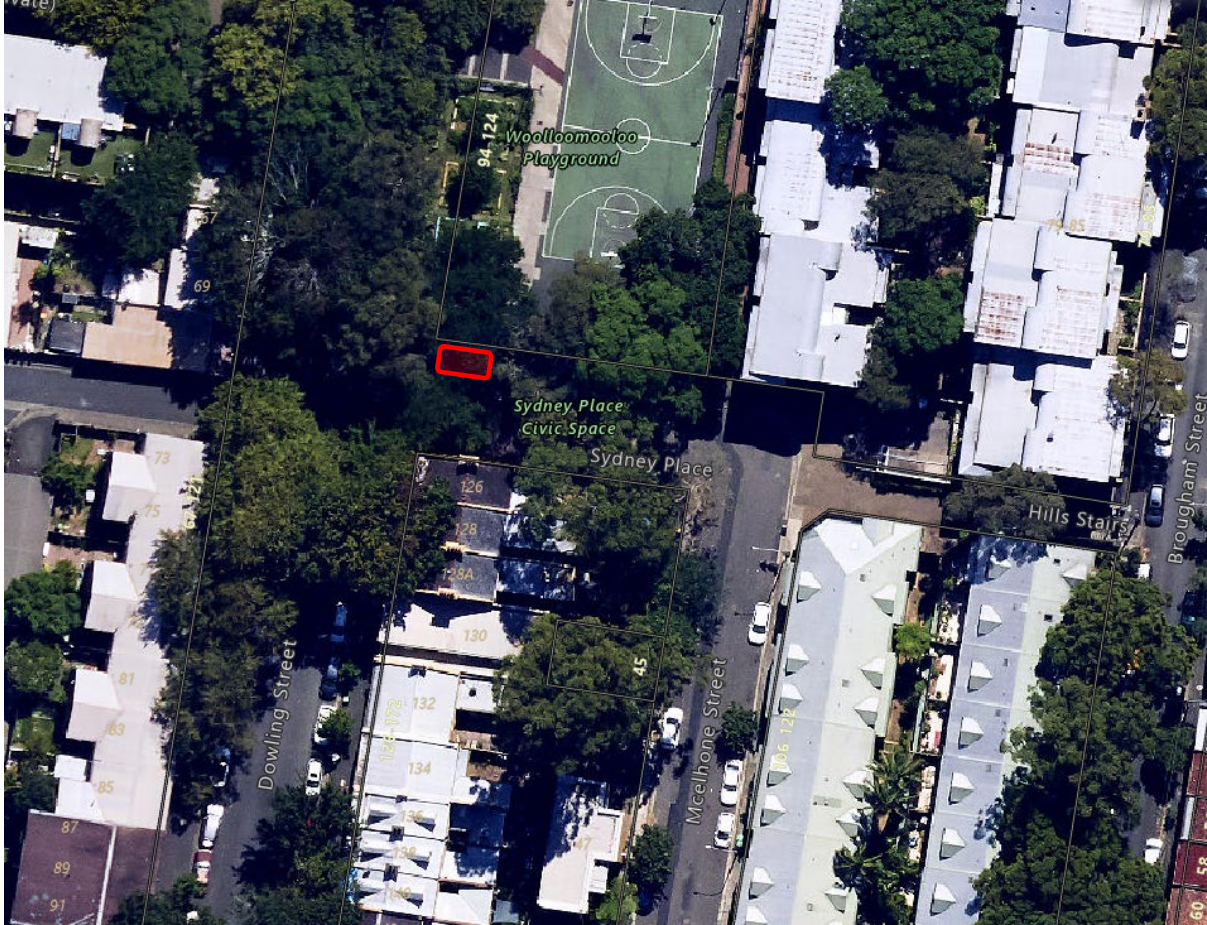
- concerns the APT will attract antisocial behaviour and drug use and therefore will affect the safety and amenity of the surrounding area
- concerns proposed location will impede pedestrian thoroughfare
- objection to 24 hour operation
- the facility will be unsanitary and create unpleasant odours
- the proposal will reduce local property values
- existing temporary toilet should be upgraded
- request for the APT to provide a baby change facility and facilitate all abilities access

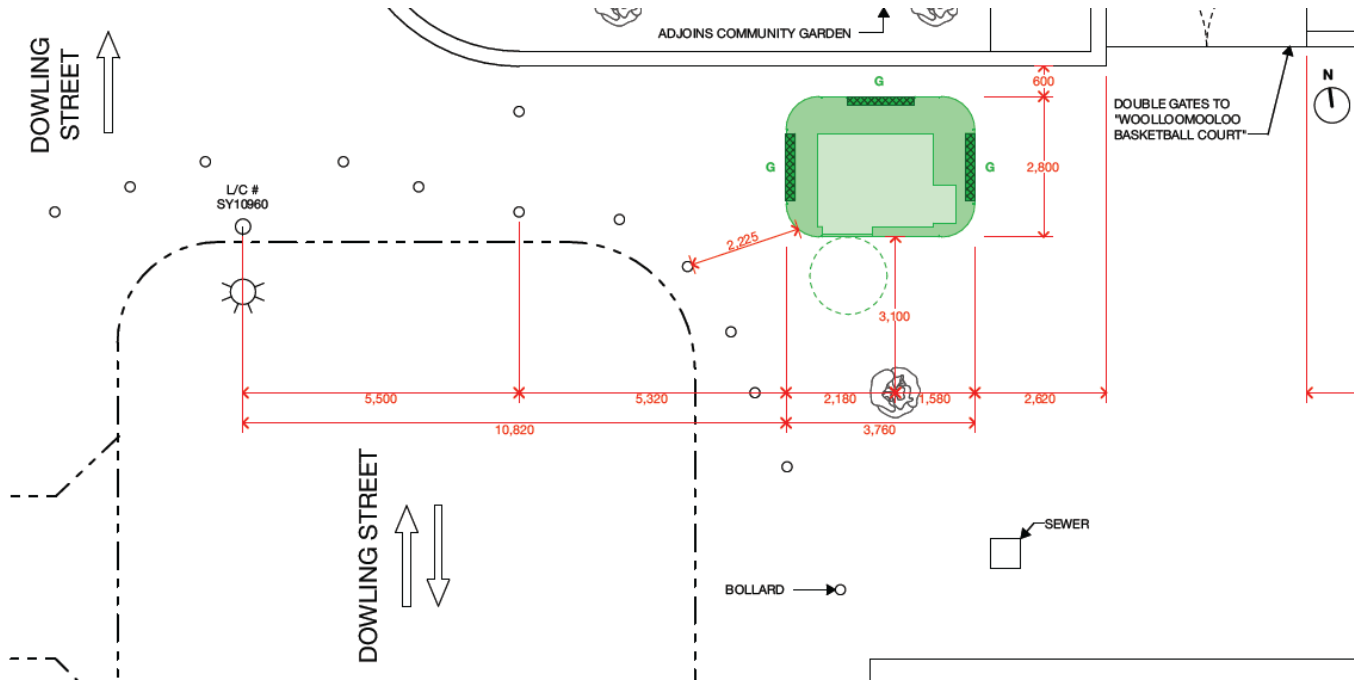

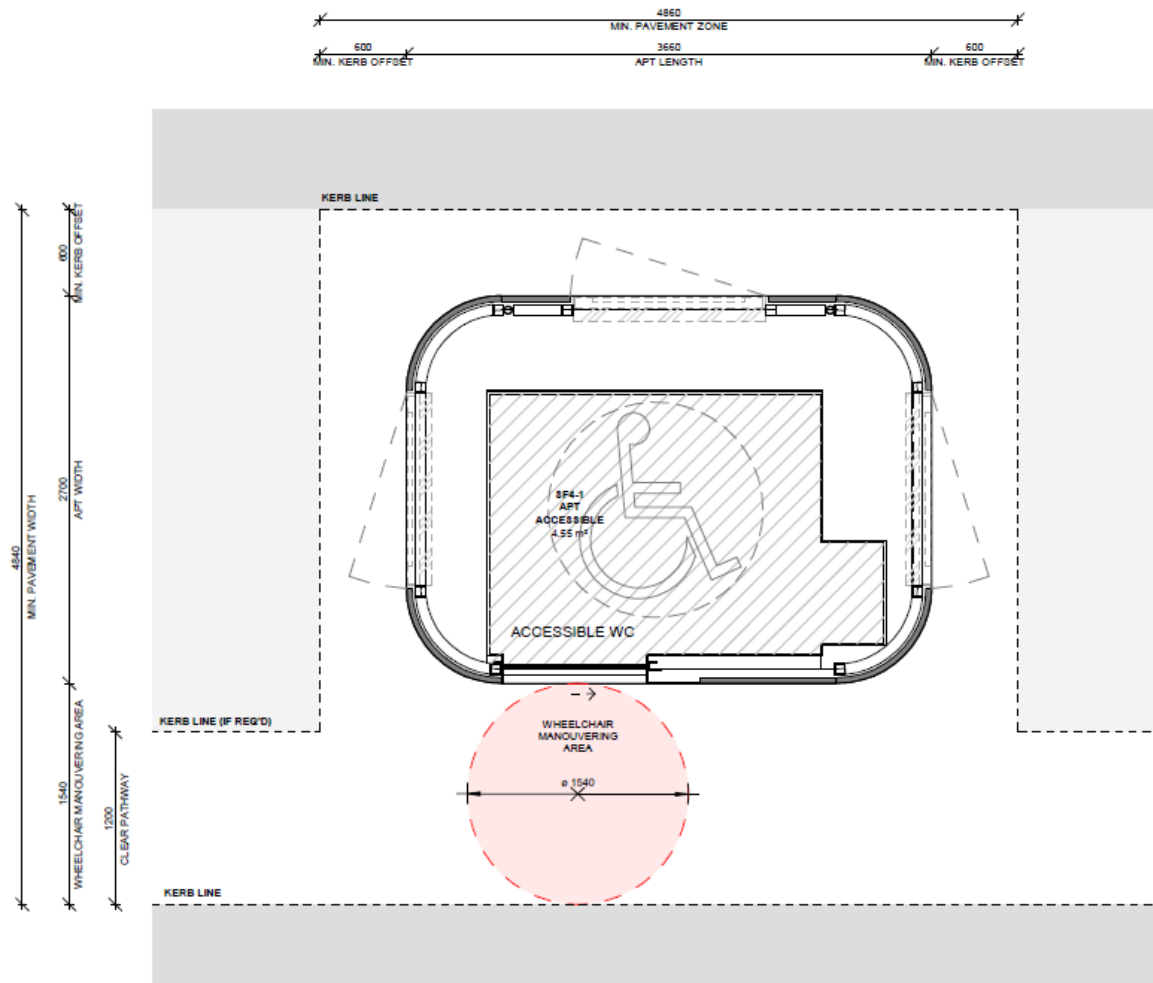

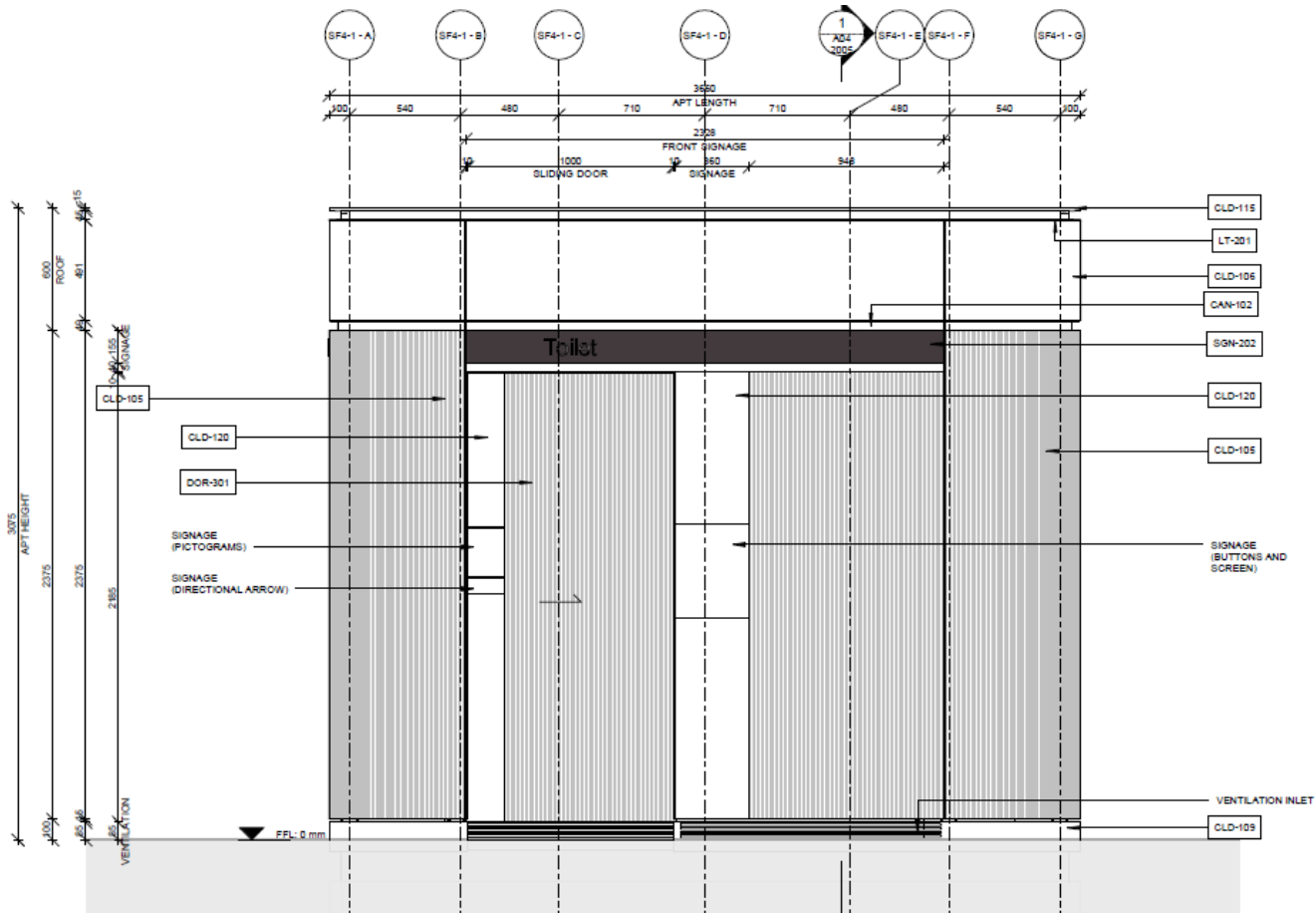

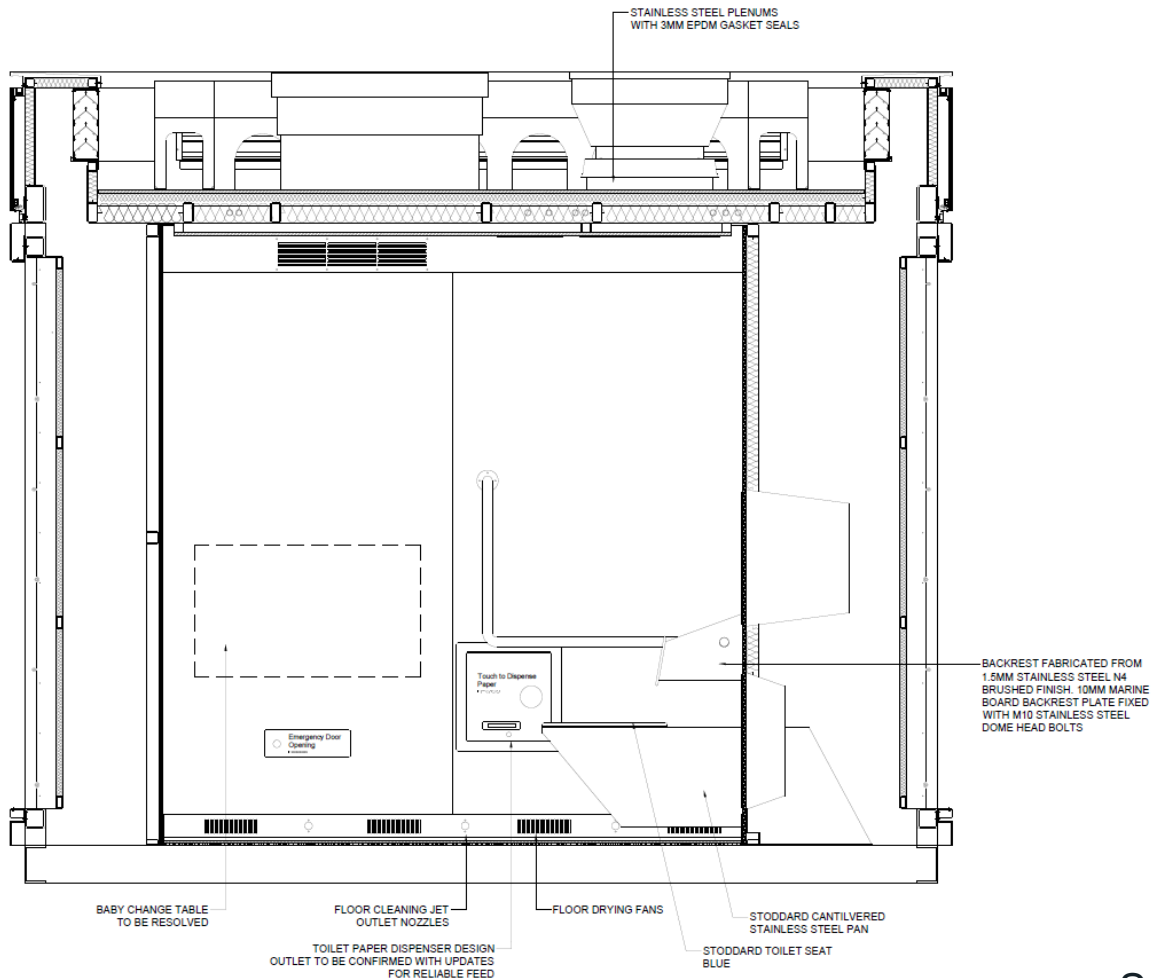
Floor Plan



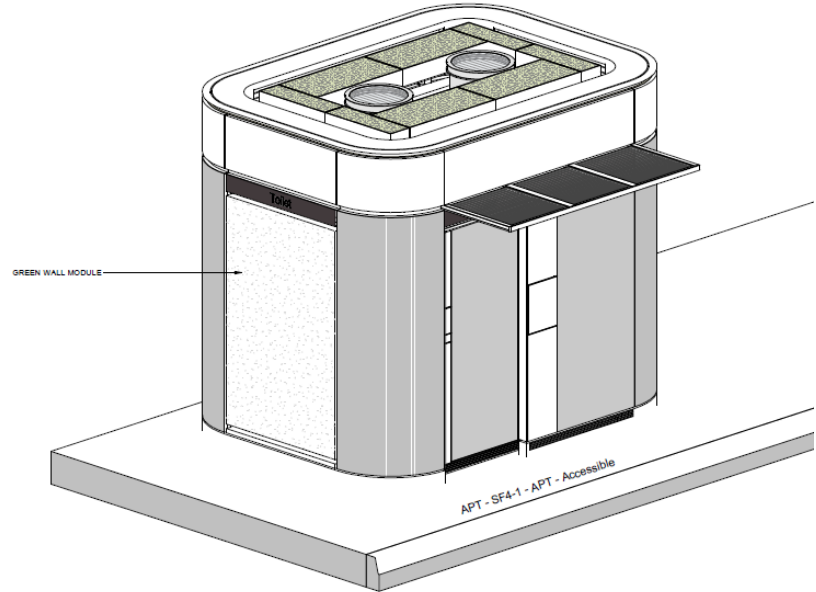
front (south) elevation

Brushed 4BF, 316 stainless steel with machined openings



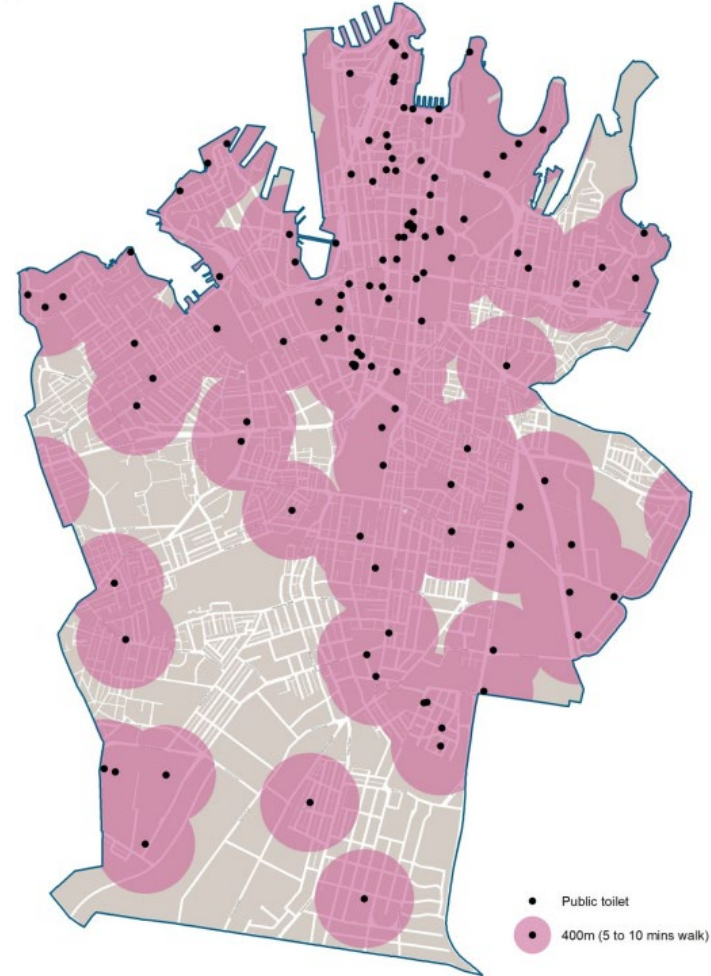

Public Toilet Strategy 2014



- strategy identifies a lack of public toilets in key locations
- recommends public toilets are provided within 400m (5-10 min walk) of all village centres and major neighbourhood parks



Urban Design Analysis

- prepared by Grimshaw Architects
- analysis of proposed location and alternative locations considered

Design Advisory Panel

- Panel reviewed the application on 15 June 2023
- no objection was raised by the Panel to the proposed location

Issues/submissions

- No evidence that APT's attract antisocial behaviour
- Impacts on pedestrian thoroughfare addressed by proposed relocation
- APT is unnecessary – public toilet strategy identifies demand for facility in area
- maintenance of the facility will be managed by QMS and City of Sydney
- existing temporary facility not on Council land

Proposed Location Issues

- impedes a well-used pedestrian thoroughfare
- inconsistent with CPTED principles as it obstructs sightlines and creates a blind spot
- creates a pinch point and inconsistent with TfNSW Walking Space Guide



Alternative Recommended Location

- to east side of access to playground
- maintains adequate space for free movement of pedestrians and wheelchairs/prams
- provides good passive surveillance
- feasible connection of services



Re-location Condition

- applicant has requested condition to allow relocation of the APT up to 5m
- previous applications for smaller street furniture items approved with condition allowing possible relocation of item/s up to 3m or 5m subject to specific parameters
- not considered appropriate for the subject application – this is consistent with previous LPP determinations of APT applications

Recommendation

- approval subject to conditions
