Community facilities approved fee waiver requests – Quarter 2 2023/24

In a report adopted by Council on 27 June 2022, information was requested to track fee-waived and discounted community hire in 2022/23 to support the community to recover from the Covid-19 pandemic.

Between 1 July 2022 and 30 December 2023, a total of 150 requests have been approved for a Covid-19 fee waiver for community venue hire for local community groups. This includes 11,054.75 hours of use to the value of \$314,511.49. This includes one booking for \$801.50 that was approved for 7 hours in Q1 2023/24 but not included in the report.

In the second quarter of 2023/24, 27 requests have been approved. This includes 2,815.75 hours of use to the value of \$61,913.12.

Major Legal Issues – Quarter Q2 2023/24

Discount Compound Pharmacy Pty Limited v Council of the City of Sydney

This is a dispute between the City and a tenant in relation to the lease for the basement, ground floor and Level 1, 295-301 Pitt Street, Sydney. The tenant is significantly in arrears. The parties previously attended mediation but no settlement was reached. The tenant has lodged an application with NSW Civil & Administrative Tribunal (NCAT). The City has filed a cross claim and is seeking to have the proceedings transferred to the District Court given the amounts involved. The parties are currently in settlement negotiations. The matter is next listed on 6 February 2024.

Byrne Civil Engineering Constructions Pty Limited v Council of the City of Sydney

This claim was issued in the District Court against the City for an unpaid payment claim made in November 2021 in relation to a project at Joynton Avenue and Zetland Avenue, East Zetland for the construction of stormwater drainage. The City has filed a defence and a cross claim relating to the City's costs of rectifying defective works and a payment made on account. The parties are due to serve evidence by 28 February 2024. The Court has ordered the parties attend mediation on 27 March 2024 and the matter is listed for directions on 16 April 2024.
