

## Inspection Report 15 Bligh Street (6-10 O'Connell Street) Sydney



## Council investigation officer Inspection and Recommendation Report Clause 17(2), Part 8 of Schedule 5, of the Environmental Planning and Assessment Act 1979 (the Act)

### **Executive Summary**:

Council received correspondence from the Commissioner of Fire and Rescue NSW (FRNSW) in relation to the subject premises on 12 January 2024 with respect to matters of fire safety.

The premises subject of the report prepared by FRNSW relates to a Class 6 restaurant tenancy known as Hubert. The tenancy is located on the ground floor of a 27-storey commercial building located close to the intersection with Bent Street, Sydney.

An inspection of the premises undertaken by a Council investigation officer in the presence of the operations manager revealed no significant fire safety issues within the building.

The premises are equipped with numerous fire safety systems (both active and passive) that provide adequate provision for fire safety for occupants in the event of a fire. The annual fire safety certification is current and compliant and is on display within the building in accordance with the requirements of the Environmental Planning and Assessment Regulation 2021.

Council investigations reveal several minor fire safety "maintenance and management" works to attend to, such as defining clear egress paths throughout the service floor, and the fire isolated exit to be kept clear of restaurant storage however the overall fire safety systems provided are adequate in the circumstances.

It is considered the above fire safety works are of a degree which can be addressed by routine preventative and corrective maintenance actions undertaken by the owner's fire service contractor(s) through written instruction from Council.

Observation of the external features of the building did not identify the existence any potential combustible composite cladding on the façade of the building.

Council investigations have revealed that the overall fire safety systems provided within the building are considered adequate.

Fire and Rescue NSW conducted an inspection of the subject premises after receiving correspondence indicating concerns with fire safety from the subject tenancy.

## <u>Issues</u>

The report from FRNSW detailed a number of issues, in particular:

#### **INSPECTION REPORT**

Concern in Writing	On Nov 27th, the restaurant seated a party of 12 that spread into the emergency exit area. Had there been a fire emergency, tables and chairs would have slowed any exit.

#### 1. Investigation Details

The following items are provided to the Council as part of the investigation on Thursday, 14 December 2023:

- 1A. The powers of an investigation officer were used to inspect the concern to determine whether there was a breach in any codes, policies, or legislation that may be considered an offence concerning:
  - A. The safety of persons in the event of fire.
  - B. Part 15 of the Environmental Planning And Assessment (Development Certification And Fire Safety) Regulation 2021 (EPAR2021) regarding fire notices, fire exit areas, and doors.
- 1B. The inspection assessed whether or not the Provisions for Fire Safety were present at the premises and whether or not Regulation 112 EPAR2021 was compliant.
- 1C. A visual inspection was conducted of the areas in the building accessed at the time. Photos were taken of the areas, including photos of the essential fire safety measures in the areas accessed. Discussions with the Operations Manager were also noted.

#### 2. Fire Safety Inspection

The following is provided as part of the investigation:

- 2A. Evidence to Conduct an Investigation
  - A. Tables and chairs were observed within the fire-isolated stairs.
- 2B. Provisions for Fire Safety
  - A. The Operations Manager advised the following:
    - i. The time leading up to Christmas results in additional bookings within the restaurant.

- ii. At the time of the complaint, they may have connected the tables in front of the exit. The Operations Manager also indicated that this does not typically happen.
- iii. When questioned about the position of the tables/chairs encroaching on the path of travel to the exits, he confirmed that this is the typical configuration of the table and chairs.
- iv. When questioned about the fire-isolated stair being used for storage, he indicated that he was unaware of the stored items being there.
- v. When questioned about the exit door without door hardware and a magnetic lock, he indicated that the door releases upon activating the smoke detection system.
- B. Exit signs above the exit doors were between bottles on a shelf. Whilst the exit signage is not obstructed from view, its location on the shelf appears similar to the bottles as a decorative feature.
- 2C. Regulation 112 of EPAR2021
  - A. During the inspection, the exit door did not appear to be hindered by tables or chairs, as identified in the written concern.
  - B. The paths of travel to fire exits within the restaurant did not appear to be hindered in a way that would be considered obstructed. However, it seemed to be less than 1 metre due to the restaurant's layout of the tables and chairs.
  - C. The 'fire safety notice' was displayed within the fire-isolated stairs under Regulation 108 of EPAR2021.
  - D. Chairs, cardboard boxes, milk crates and cleaning liquids were located under the flight of stairs in sight of entering the stairwell. Despite this, the stored items did not appear to block or hinder the movement in the 'fire exit area' or the 'fire exit door' for the occupants moving within the stairwell under Regulation 109 of EPAR2021. They were removed immediately upon the Operations Manager becoming aware of the items in the stairwell.
  - E. The lever handle exit door to the fire-isolated stair opened without obstruction. However, the exit door leading to O'Connell Street via the arcade requires a button to release the magnetic lock, which is located on the left-hand side when facing the door.

#### 2D. Outcomes

- A. The operations manager was directed to ensure at all times:
  - i. The fire-isolated stairs are not used for storage and remain clear of all items.

- ii. The exit paths within the service floor of the restaurant are kept clear of anything that may obstruct the free passage of patrons to the exits.
- B. During the inspection, no obstructions were observed in the fire exit area or door outlined in the written concern to provide sufficient evidence of violating the required standard of proof. As such, the inspection does not provide reasonable grounds for further investigation.

#### 3. Possible Non-Conformities

- 3A. The Council may need to ensure the following:
  - A. The owners maintain the essential fire safety systems and meet the local Council's obligations to regulate the development consent approval, particularly the layout of the dining tables and chairs.
  - B. An accredited practitioner (fire safety) has assessed, inspected and verified the performance of each fire safety measure (including exits) that applies to the building. Furthermore, the owner submits an Annual Fire Safety Statement (AFSS) as part of their obligations under the EP&A Act.
- 3B.
