Please keep my name and email address confidential when publishing.

I am a local resident writing to voice my concerns regarding the proposed installation of an automated public toilet at 116-126 Erskineville Road, Erskineville by the digital street furniture advertiser QMS Media.

I object to the proposal on the following grounds:

- This is the third attempt by the same digital advertising company to install a public toilet against the wishes of the local community. It is an abuse of the council's DA process and a waste of ratepayer funded resources for this business to repeatedly submit applications in the hope that something will "get past council", particularly given the strength of community opposition regarding prior proposals.
- The proposed siting is admittedly an improvement on previous locations, but nonetheless remains unsatisfactory. The Burren Estate is a heritage conservation area and any attempts to alter its heritage significance should be approached with caution. The proposed APT is an unaesthetic non-contextual intrusion into the fabric of the conservation area with a modern and ungainly bulk and is composed of materials which are reflected nowhere else in the Burren Estate. Whilst APTs have been installed elsewhere in the City of Sydney area, Erskineville Road is perhaps the only high street in the council which continues to retains its "village feel" (and very successfully despite the increased density resulting from the development of the Ashmore Estate and Park Sydney apartment blocks). Council should do its utmost to protect the unique heritage and character of the area, which is extremely rare and not easily replicated elsewhere.
- The Ellen Lawman lawn area is the location of council's annual Christmas tree, which is popular every year in the Erskineville community. Given the small size of the lawn area and the very large size of the Christmas tree, it would be difficult from a safety perspective and undesirable to co-locate the Erskineville Christmas tree next to a toilet. I have included a picture of the Christmas tree as an attachment to illustrate its scale and vibrancy. It does not appear council has identified any viable alternate sites where the Christmas tree could be located (most likely because no other such site exists).
- There are already existing public toilets at the Erskineville Town Hall, Erskineville Train Station, Budget Petrol Station and Erskineville Oval, so the proposed APT is of limited additional amenity (particularly during daylight hours). It is both feasible and more economical to focus on improved access hours at these sites. It is unclear why the supporting environmental documents to the QMS proposal so easily dismiss these possibilities.
- Based on the history of past APT sites in the City of Sydney and other local council areas, the proposed
 development will inevitably become a site for drug taking activity, sharps and other drug paraphernalia, and other
 nefarious elements. QMS Media has made no proposal to satisfactorily reduce this risk (other than
 "monitoring").

This delay has contributed to an over 60% increase in the estimated cost from \$275,000 to \$413,000. This excessive cost is a concern, and I would appreciate an explanation as to why this is the case.

Further, given this high cost, would modifying the existing public toilets at the Erskineville Town Hall be a more economical and aesthetically acceptable solution?

While the proposed location makes sense because of its proximity to a bus stop and the village precinct, given the recent upgrade plan submitted for Ada Villa Terrace, is there a reason the Council did not consider this location for the facility?

The big question in relation to the proposed toilet block in the Ellen Lawman Rest Area Erskineville is 'why'? Why is the toilet facility necessary? There haven't been any public movements (no pun) demanding a toilet, no local marches, no letters to the editor. Nothing; not a squeak from the local community. The proposed toilet is unrequested and there are plenty of nearby toilets available to the public in the 3 nearby hotels and at the railway station. I have been a local resident for 40 years and here has not been a noticeable need for after hours toilets in the area.

Is this proposal a thinly disguised 'make work' gambit for the proposer? An income stream, not only in the building of the toilet box, but the development of an ongoing, multi-year annuity through the regular cleaning and maintenance of the toilet. That would make sense, especially if the proposer has a number of similar proposals in the pipeline, collectively the income could be a considerable council expense. There may well be a question of unnecessary expenditure of public fund which could be wasteful at best, and potentially fraudulent at worst.

Regarding the State of NSW and Department of Planning and Environment Guidelines

Small parks are a key amenity of a park-starved inner city. Small pocket parks, like the Ellen Lawman Rest Area, are important heritage assets that the community can enjoy. The proposed toilet block irrevocably impairs the heritage value of the park. The structure will significantly reduce the availability space the community enjoys. The buildings's impact goes well beyond the physical dimensions; there will be little enthusiasm to spread out a picnic blanket in the near proximity to a public toilet, the effective size of the small park will be considerably reduced at a cost to the community. People enjoying the remaining space in the park will have their view impaired as their view will be obstructed by the toilet block.

Some buildings might add to the visual amenity of a precinct, the Opera House, for example is a key cultural and visual asset on the edge of the harbour. Its safe to say the proposed toilet block is no Opera House, nor physical cultural addition, nor will it add to the beauty of the small park. Putting flowers on a wall of the shed-like structure will not suddenly transform it into the hanging gardens of Babylon, rather a poor attempt at lipstick on a pig.

The scale and materials are quite incompatible with the immediate area. The proposed structure has no obvious connection with any nearby buildings. It may be in keeping with other toilets scattered across the council area but its a long reach to say that something that looks like space debris has any obvious similarity to the local shopping area and park. Even the bus shelter is more sympathetic, in scale and material, to the local precinct.

The siting of the building is in a position that is completely and unnecessarily indiscreet. If a public toilet is an essential public facility for the village, site it in an area that is less noticeable, like behind the florist shop in that back corner of that park, or on the road closure next to the railway station. Simple and clear signage can direct the community to more discreet locations.

The proposed works may be part of a broader scope of works, but the question is 'does a disconnected, scattered scope of work justify the imposition of a bland toilet block in the Ellen Lawman Rest Area?' The answer is a clear no. The Ellen Lawman Rest Area intact, should remain solely a small park, a public recreation area, not a public defecation area.

The contemporary design of the toilet block would be clearly recognisable as an ugly, unnecessary new element within the heritage conservation area. There is no sympathy with the tin box structure to any of the nearby heritage buildings in the Burren Estate Heritage Conservation Area.

The assessment of potential heritage impacts by City Plan is at best a work of fiction; confected to make a silk purse out of a sow's ear. The conclusions only make sense in a superficial manner and don't reflect the reality of the damage that will be done to a convenient little village park. The loss of amenities to the community will far outweigh the alleged benefit.

As I noted in my earlier submission when the toilet block was initially proposed for the small parcel of land next to the Thai restaurant, the proposed is a shit idea and remains, in this incarnation, a shit idea.

I am writing to oppose the development of a public toilet in Erskineville park on Erskineville road.

- * This park is a place for gathering and sharing of green space, of which there is very little in our community. People picnic in this park, my children eat ice creams on the park bench, the annual Christmas tree is erected in this park. All of which bring enjoyment to my family and others in the area. Building a PUBLIC TOILET in this space smack bang in the middle is unsightly and not keeping with the aesthetics of the area. It will deter people away from the pleasant green space, force the relocation of the Christmas tree (who wants to be enjoy a glorious festive tree next to a stinky toilet) and simply be an awful eyesore. It is a complete separation of the environment it is proposed to be in. A more fitting space would be the built up seating area next to the Erskineville Anglican church on erskineville road. It would fit within the built up environment rather than completely ruining beautiful green space.

I refer to the above application. Despite two prior applications for the installation of a public toilet in Erskineville village being denied, we find QMS trying for a third time. This is despite the majority of residents objecting to it previously. The location, once again, is totally inappropriate as well.

My objections to the current proposal are as follows -

- Erskineville is not a bustling 24/7 economy and, as such, there is no need to provide an out of hours toilet in our village there are plenty of bathroom options available the train station as well as the local pubs, restaurants and cafes during the day and well into the evening should they be needed
- the first DA submission for the toilet argued against taking up green space for construction but this submission now puts one in green space. The space suggested is small, is right in the centre of our village and backs on to a child care centre. It's a space that is enjoyed by many people who can sit there and relax and enjoy village views. The submission shows that the toilet will be front and centre of the park which blocks any views and also makes the view for any patrons in the bars and restaurants on the other side of the road unsightly
- public toilets, no matter their location, are always dirty, attract antisocial behaviour such as drug taking and are a regular target for graffiti. This is not something that our village should be exposed to
- the proposed structure does not in any way blend into the streetscape. It is just a "one size fits all" build that will stand out and ruin the aesthetic of the village which is part of a conservation area. I write in response to the DA proposing a public toilet be installed in a park near Erskineville Station.

I admit to being baffled by the nature of the Statement of Environmental Effects. Table 3 provides an assessment against the various Zone Objectives, where the assessment team seems to misrepresent the level of compliance with a whole series of objectives as follows:

To enable land to be used for public open space or recreational purposes – rated as complies, despite the fact that public open space is objectively reduced from what currently exists and significantly affects the degree of recreational use possible in the park.

To protect and enhance the natural environment for recreational purposes – rated as complies, despite destroying existing vegetation cover of the open space, having a risk of damaging the trees, and making that portion of space unavailable to recreational purposes rather than enhanced.

To retain and promote access by members of the public to areas in the public domain including recreation facilities and waterways and other natural features – rated as complies, despite reducing access to the natural features of the park and blocking sightlines through the green space.

It makes zero sense to destroy preciously limited parkland for the purposes of this installation when there is plentiful alternative public land at this location that is being underutilised – namely, for the private storage of multi-tonne hunks of metal in a dense urban space well served by public transport. The elimination of a single car space, either kerbside or at the nearby car park, for the placement of this toilet would actually enhance the streetscape by providing much-needed traffic calming in a high foot traffic area, as well as enhancing the green space through addition of the green walls in a currently concreted environment, while preserving the integrity of the park in its full size.

I am writing to you in response to DA/2024/129, regarding the proposal to install a toilet in the Ellen Lawman Rest Area.

I am opposed to the council sacrificing our critical public green space to accommodate QMS Media's proposal. The public amenity of parks and open spaces is incredibly valuable and difficult to recover when lost. The Ellen Lawman Rest Area has been an iconic gathering point for locals, and the value and utility of the space would be drastically diminished by constructing the toilet in this location.

While the toilet itself would not occupy the entire area, it's position would critically sabotage the landscaping of the area, by breaking up the open space, it would discourage people from entering, and create an area behind it where visitors would not feel safe to enter, risking a spiral of decreasing use.

It has been raised that a toilet is necessary in the area to accommodate people when the train station and pubs are closed at night, however Appendix 8 suggests the toilet will be closed at night time and re-open in the morning, meaning the toilet would be unable to fulfil this need.

Additionally, the noise created by the toilet announcing the entry of users would be a nuisance to the residents living near the rest area.

There is actually a great deal of space available to service the area with a toilet amenity, consider that we could simply replace one car parking space on Erskineville Road with the toilet. This would have the added benefit of traffic calming on a road where we have just had a serious crash with a pedestrian which has lead to calls for the council to achieve this very goal.

If the council does not see replacing a parking space with the toilet as viable, then another option would be to utilise the town hall, and invest in making the existing toilet facilities there accessible in a way that meet the requirements for a public amenity.


The space is secure and has an alarm system. All that would be needed for security is to ensure the internal doors to the rest of the building are securely locked.

Although there are a number of technological features of the automated public toilet, they aren't really necessary, when one considers that the regular toilets in Sydney Park are considered sufficient and are not of this automated type.

This automated public toilet also uses part of the pocket park and the impact of the new plumbing necessary on the root systems of the trees is unknown. I am opposed to losing green space in Erskineville when an alternative is feasible.

Dear Council,

We are strongly opposed to losing green space within our limited pocket parks along Erskineville Road, and in Erskineville.

This is the 3rd application by QMS media to install an automated and talking toilet unit in our limited public spaces along Erskineville Road. Whatever is the commercial contract with Council and this company? The cost for the installation is ridiculously high and on many levels impractical!

The proposed location within our pocket park between Charles and John Streets leads to loss of valuable open green space available in our community. This location has been chosen by Council for the past few years as the site for the Council's Christmas tree. This site is regularly used by community for sitting, for taking food from local restaurants to sit and eat, for socialising. This pocket park site also adjoins a private residence that fronts both Charles and John Streets. An automated talking toilet unit will totally destroy the green space in this location, resulting in a loss of amenity to our community. And how could it be located on a site adjoining a private residence?

We live on Erskineville Road and there is no sewer line on Erskineville Road, meaning all digging to connect to the existing sewer line needs to be deep and extensive to connect to Baldwin Street. Where will the digging need to be to connect to existing sewer line locations to accommodate this proposed toilet unit?? Digging for the required plumbing will likely lead to the disturbance of established mature tree root systems & probably kill the trees. This green space pocket pack has native fig trees and also native Riberry trees along the 3 perimeters, all with decent canopy, and this adds to the appeal of our pocket park. An automated talking toilet unit will not add to the appeal that exists in this green space.

Sensible solution: Less than 70 metres along Erskineville Road from this pocket park site is our Erskineville Town Hall. Our public building. In two locations within the Erskineville Town Hall there are pairs of public toilets, for men and women, unisex, baby change and wheelchair access. Photo of Erskineville Town Hall attached. External doors on the left lead directly to a foyer, and internal door on the left labelled "Gentlemen", internal door on the right labelled "Unisex/baby change, and wheelchair access". Beyond the foyer are doors to the main hall. These doors could easily be locked so as to be inaccessible to the public, making the existing public toilet facilities available to the public. The entry can easily be modified for disability access, as has been done recently to access the main entry doors. We have emailed also to Councillors requesting a site visit to the Erskineville Town Hall, and see how sensible and effective this solution for public amenity is.

We do not believe we should be losing our open green spaces in pocket parks when it is not necessary.

I'd like to add my objection, on the basis of:
