**Summary**

## Background

1. Each year the Central Sydney Planning Committee (CSPC) considers a meeting schedule for the upcoming year.
2. The draft schedule proposes 10 meetings and 10 briefings for each calendar year.
3. CSPC meetings are generally scheduled in the same week as meetings of Council's Transport, Heritage and Planning Committee.
4. At its [meeting of 22 September 2025](#), Council adopted meeting schedules for 2026, 2027 and 2028. Consequently, it is possible to schedule 3 forward years of CSPC meetings.
5. It is possible the Lord Mayor may need to adjust the meeting dates for Council and Council Committees if any unforeseen issues arise.
6. Should this occur, the CSPC meeting dates will be amended accordingly, with CSPC Members to be notified as soon as practicable and the City's website updated accordingly.

## Critical Dates / Time Frames

9. The schedule follows the same pattern as previously approved by the Central Sydney Planning Committee. Meetings are generally scheduled in the same week as meetings of Council's Transport, Heritage and Planning Committee.
10. The commencement time for the public meeting of the Central Sydney Planning Committee will be 5.00pm.
11. Briefings are generally held the week prior to the Central Sydney Planning Committee meeting.
12. Following endorsement by the Central Sydney Planning Committee, meeting dates will be available on the City's website.
